Letter from the President and Chair

We are honored to present the Annual Report of The Foundation for Enhancing Communities for the year 2017 for your review.

The Foundation for Enhancing Communities (TFEC) and our six regional foundations, which include the Camp Hill Area Community Foundation, Dillsburg Area Foundation, Franklin County Foundation, the Greater Harrisburg Foundation, Mechanicsburg Area Foundation, and the Perry County Community Foundation, had another very successful year. We ended the year with a total of 44 new funds, management agreements, and projects. Our total contributions for 2017 were \$10.5 million which brings our total assets to \$97,430,953. Reaching this new pinnacle of growth is very exciting!

Jeff Mattern from Newport, in Perry County, assumed chairmanship in January 2017 and has provided us with excellent leadership. We welcomed three new board members. including Devin Q. Langan of Legacy Business Advisors, L. Renee Lieux, an attorney with Bybe Rutledge LLP, and Gregory J. Royer, owner of Royer's Flowers. We said goodbye to two board members: Kathy Pape of McNees Wallace & Nurick LLC, our chair for two years and Mike

Gillespie of Hersha Hospitality Trust, our treasurer for four years. We sincerely appreciate their service over the past years and wish them well in their future endeavors.

Thirteen members graduated from our Emerging Philanthropists Program (EPP), which is our partnership with Harrisburg Young Professionals (HYP). We have graduated a total of 50 young adults from the program over four years. They granted a total of \$20,000 to various nonprofits over the four years. The first class established an endowment fund called the "EPP Fund" to grow an endowment for the future work of the EPP program. They will be sponsoring the Harrisburg Hoopla, a day of field games on City Island, good food, and bands on June 2nd. The EPP Fund will benefit from the event. We hope you will support them and attend.

Our Women's Fund held the Annual Grantee Recognition Breakfast in March, and the Power of the Purse in November. In 2017, Karen F. Snider, a member of our board of directors and a member of the Women's Fund Advisory Committee, passed away. To honor her, we renamed the Women in Philanthropy Award, the Karen F. Snider Women in Philanthropy Award. Carolyn

Dumaresq and Betty Hungerford were honored for their extraordinary and generous service to the community in 2017. We were honored to welcome 50 new Dream Team members. Elaine Nisslev served as our capable chairwoman in 2017.

Our strong, dedicated and cohesive team of professionals are most critical in meeting the strategic goals and objectives of an evergrowing, flexible, ever-adapting organization. We welcomed Tommy Bradley, our Community Investment Associate to the team this year. We are pleased to thank Spencer G. Nauman, Jr., Esg. and Steve Feinour, Esg. of Nauman, Smith, Shissler & Hall, LLP for their exceptional legal advice, and Connie Siegel of ConradSiegel for his volunteer guidance and leadership in the area of investments.

We could not do what we do each year without you, our donors. You provide us the ability to partner with you to achieve your charitable gifts as you support your favorite charities. Your dedication and commitment to making the region a better place to live, work, and play is a precious gift we cherish and value through your leadership and generous sharing of resources. The Women's Fund annually honors local female philanthropists with the Karen F. Snider Women in Philanthropy Award, given to individuals who are outstanding contributors of their time and talent to benefit the lives of women and girls in our area. In 2017, we were honored to recognize Dr. Carolyn C. Dumaresq and Betty C. Hungerford, who joined the ranks of 15 other award recipients.

This year's award was especially notable as it was renamed in memory of Karen F. Snider, a wonderful friend of the Women's Fund, who passed away in 2017. Karen, the inaugural recipient of the award in 2011, embodied its criteria – she dedicated her life to improving the lives of others, gave freely and selflessly of her time and resources, and was an inspiration to all who knew her.

Community Check-Up Center of South Harrisburg, Inc.

In 2017, the Women's Fund was pleased to award the Community Check-Up Center of South Harrisburg a \$2,090 grant to help provide LARCs - Long Acting Reversible Contraception - for uninsured women, which is key to giving women the opportunity to choose when they make the decision to start a family.



"Long-Acting Reversible Contraception (LARC) is an effective, convenient method of birth control. Because it is long-acting, it is a popular method among our patients and it is also an expensive method. Depending on the device chosen, it can cost anywhere from \$50 to \$325, and, because the hormone level differs in each device, the method of choice must be determined by a patient's needs, not by cost. The Community Check-Up Center is extremely grateful to the Women's Fund for their continuing support for this impactful program."

Scholarships

When you create a scholarship fund, you can choose a restricted or committee advised fund and make it either permanent or nonpermanent.

You determine the criteria for your scholarship such as financial need, class rank, GPA, leadership, etc. You can select scholarship awardees with the assistance of a committee using your criteria or assign a committee to make the decisions. TFEC administers the award process and payment of all awards each semester. Scholarships may only be used towards the cost of tuition, fees and/or books.

New Scholarship Funds Established in 2017

Faerie L. Angle Memorial Scholarship Fund Faerie L. Angle was the widow of Rov S.F. Angle, Attorney-at-Law. Her Last Will and Testament provided for the creation of a Law School Educational Trust Fund which provides "scholarships for young persons from Franklin County, Pennsylvania, studying to be lawyers".

Edmund A. Brenner, Jr. '52 Scholarship Fund This scholarship was established in memory of Edmund A. Brenner, Jr. by his younger brother, Robert Brenner. Edmund was an avid supporter of Bishop McDevitt High School, especially their sports events. The fund provides a one-year scholarship to Bishop McDevitt for an eighthgrader from the Nativity School in Harrisburg with the highest scholastic rating and financial need.

Education Matters - The J.M. Heberlig and B.J. Helterbran Scholarship Fund Education matters and it is becoming more difficult than ever to afford to reach your goals. Together with family, friends, and community, we can all accomplish great things. Jody, a High School Art Teacher, and Beth, who has worked in Recreation and Parks for over 30 years, both came from families that valued and promoted education and benefited greatly from their support and encouragement. Funds will be designated toward tuition for students attending a Pennsylvania College or University and studying Art Education and/or Recreation and Parks.

James G. Hewlett Memorial Scholarship Fund Established as a fund of the Franklin County Foundation through the estate of James G. Hewlett, this scholarship supports Franklin county residents who are studying nursing or other medical support occupations. The fund is intended to support students who are working towards their undergraduate degree, but will support graduate students if there are not any eligible undergraduate applicants.

Dorothy M. Peele Scholarship Fund This fund was established as a fund of the Mechanicsburg Area Foundation to honor Dorothy M. Peele who taught Physical Education and coached girls' sports at Mechanicsburg Area Senior High School from 1957-1966. She was a devoted educator, mentor, and role model and had a positive impact on many students' lives.

William Atchley Reed & Maxine S. Reed **Memorial Scholarship Fund**

This scholarship was established through the estate of Maxine S. Reed to support students attending Dickinson College with a preference being given to students studying architecture.

The Elaine and Robert Siegel Scholarship Fund This fund was established to support collegebound students from Harrisburg.

The Emerging Philanthropist Program (EPP) provides resources and educational opportunities for Harrisburg's developing leaders who wish to be actively engaged in giving back to their community.

Engaging Harrisburg's next generation of philanthropists

Since 1983. Downtown Daily Bread (DDB) has operated under the belief that addressing basic human needs is the first step in lifting its clients out of homelessness. DDB serves the hungry and homeless of Harrisburg. providing a daily lunch



and other services, including lockers, bus passes, transportation, photo identification resources, haircuts, laundry tokens, mail delivery, and food vouchers.

Workshops for Living (Daily Lessons in Essential Life Skills) provides meaningful life skills lessons to transitionally homeless and at-risk populations. Beginning in July 2017, Tri-County OIC and Downtown Daily Bread began a partnership to offer life skills classes to clients of DDB.

Split Interest or Charitable Trusts

TFEC manages and serves as trustee for 42 charitable trusts, valued at \$11 million (12/31/17). These trusts include Charitable Remainder Unitrusts, Charitable Remainder Annuity Trusts, and Charitable Lead Trusts. These agreements are legal arrangements where you can transfer assets irrevocably to a trust, which then invests them and creates two (split) interests. You can establish these legacy gifts in order to increase the impact of your charitable gifts, receive a lifetime income, and/or

qualify for income, gift, and estate tax benefits. Charitable trusts have a minimum \$50,000 contribution requirement. In most circumstances. legal services are required and are available to you without charge through TFEC's relationship with Nauman, Smith, Shissler & Hall, LLP.



TFEC's Early Education Initiative







TFEC Forms Early Education Advisory Committee

TFEC has been investing in early education for over 11 years beginning as Capital Beginnings in 2006 when we received the Community Engagement Outreach grant for Dauphin County. Over time, this funding has disappeared but TFEC has remained committed to the cause and continued to secure grants and contributions to maintain the work.

In 2014, TFEC was one of 12 community collaboratives across the commonwealth to be awarded a Community Innovative Zone grant from Pennsylvania's Office of Child Development and Early Learning (OCDEL). This funding was part of the \$52 million Pennsylvania was awarded by the U.S. Department of Education's "Race to the Top-Early Learning Challenge" TFEC, on behalf of our community collaborative, received Race to the

Top funding equaling \$225,000 over three years; and secured nearly \$235,000 in matching funds from local organizations and individual donors to continue our good work.

DUCATION

We remain committed to continuing this work as TFEC's Early Education Initiative.

With the implementation of the TFEC 2017-2020 strategic plan, TFEC's Board of Directors has solidified our continued commitment to early education; to take what we have learned in Dauphin County and work collaboratively with others throughout our entire service area. Our goal remains the same as it always has: wrap support around the whole family in an effort to close the achievement gap by third grade by focusing on kindergarten readiness skills.

Our first step to fostering community change was to create an Early Education Advisory Committee with representation from each county in TFEC's footprint. The inaugural meeting was held October 12, 2017. To be effective and relevant, the committee includes representatives from business and industry, community leaders, school representatives, and early learning providers. The committee will explore the systems, partnerships, and leadership roles that best enhance and strengthen connections focusing on service to children from prenatal to five years of age and their families, which is critical due to the lack of cohesiveness in the early education sector.

Kindergarten Transition Conferences

In 2017, TFEC, Lancaster-Lebanon IU-13, South Middleton School District, and the United Way of Carlisle and Cumberland County came together to host two Kindergarten Transition Conferences. Early learning providers, school district staff, and community partners serving Cumberland, Dauphin, and Lebanon Counties came together to learn how to further grow and adapt transition practices. Research shows that a seamless transition into kindergarten is critical for young children in order to be successful in their future academic careers—this transition sets the tone for their future school experiences.

On February 23, 2017, presenters provided best practices on how they handle this important transition for children, families, and educators with a focus on the Adverse Childhood Experiences scale (ACEs). The theme for the conference hosted on October 26, 2017 was "STEAM" in the early education classrooms; science and technology interpreted through engineering and the arts, all based in mathematical elements.

TFEC has been leading transition forums and conferences in Dauphin County since 2012. In 2018, TFEC plans to expand these offerings to our entire service area including Cumberland, Dauphin, Franklin, Lebanon, and Perry Counties, and the Dillsburg Area.



Robert J. Dolan, ASA, Investment Advisory Committee Chair

The past year has been a wonderful year for the financial markets. Stock prices are not only up in the United States, but stock prices are up in the vast majority of developed and emerging markets. Asia is the area with the biggest returns.

Domestic equity returns have been strong and coupled with the low inflation environment, bond prices and returns have remained relatively stable. This has allowed the Federal Reserve to raise the fed fund rate without harming economic growth. Equity returns domestically were positive in each month of the year, that has not happened since 1958. Just before the Presidential election at the end of October 2016 the DJIA closed at 18,142, by the end of 2017 it reached 24.719 an increase in the value of the index in excess of 36%. This is an historic bull market.

On top of all that, the good news is the Tax Act passed in late December on a very accelerated time table. Economists are still struggling to predict the impact; however, US Corporations appear to be among the largest beneficiaries. The decreased corporate tax rates will benefit many corporations, and if the change is successful in bringing cash that is currently being held overseas back into the US, that will have a positive impact on economic growth. The economic trends look good for 2018.

We have seen consistently rising equity markets for a long stretch. In fact, 2017 was the first year in history that all 12 months in the S&P 500 index were positive. Likewise, it is also the first time the global MSCI All-Country

World Index has risen every month during the calendar year. Thus far in 2018 we have seen some downward movement where many equity indices hit "correction" territory (i.e. – a 10% drop from the previous high point). Corrections are common, expected and often healthy when investing in equity markets.

As always, your Investment Advisory Committee continues to review asset allocation and the funds used to execute that allocation with a strong discipline to long term returns. The short term "noise" is to be avoided. The nature of the Foundation money is long term so our investment horizon is always long term. We remain committed to that philosophy.

Investment Strategy

22 years

In 1996, TFEC adopted a disciplined, passive investment strategy which suggests that we not try to outperform the market in any given year. In order to realize market returns and maintain diversification at the lowest possible cost, TFEC invests in no-load, lowexpense mutual funds. These funds, from reputable companies such as Vanguard and Dimensional Fund Advisors, are held within separate asset-class pools.

Passive vs. **Active Management S&P 500**

S&P 500 index funds, a passive investment index, have outperformed 80% of the managed general equity mutual funds over the past twenty years. Similarly, the mid-cap and small-cap index funds have outperformed actively managed funds of similar investment quidelines. Part of this performance is due to lower fees charged against indexed funds, low commissions paid on security transactions, and little asset turnover.

Total Return Philosophy 1996

Since 1996, TFEC has invested assets according to "Total Return". A total return philosophy treats all returns on investments — interest, dividends, realized and unrealized capital appreciation — as additions to principal. The spending policy then allows for more predictable distributions over the longterm and ongoing grant recipients are able to rely upon a relatively stable income stream.

Through shining her light, life, and love, we hope to inspire others to make a positive change in the world and leave their own legacy. New Projects Established in 2017

The Foundation for Enhancing Communities (TFEC) can perform many internal functions for organizations or individuals who have a charitable purpose and wish to operate as a nonprofit organization.

TFEC can help you achieve your mission through the establishment of a project, allowing you to operate as a nonprofit organization through a fiscal sponsorship agreement. This agreement allows you to access the reputation, credibility and fiscal acumen of TFEC, fundraise to support your charitable mission, give your donors taxdeductibility for their gifts and, create good records of fiscal activity. TFEC has expertise in managing a wide range of charitable projects from community health initiatives, to corporate and foundation grantmaking programs, to urban beautification initiatives. TFEC manages 65 projects totaling more than \$1.5 million in assets (12/31/17).

Dauphin County CASA

The charitable purpose of this project shall be to provide trained volunteer court appointed specia advocates (CASAs) to the Dauphin County Court Dependency Judge. CASAs are appointed on select cases of dually adjudicated dependent/ delinguent children to promote reunification with families or move to permanent placement through adoption. This limits periods of foster care for

dependent children and for delinquent children, advocates for rehabilitation to succeed socially. educationally and vocationally in the community in order to combat community deterioration and iuvenile delinguency.

Healing Gems

The charitable purpose of the project shall be to bring awareness of the healing nature of the creative arts, holistic wellness practices. and psycho-educational programs to trauma survivors, their families and community and to provide them opportunities to experience these healing modalities in a safe environment with professionals in these practices.

Lucky Duck Miracle Derby

The charitable purpose of the project shall be to provide monetary donations and awareness in support of the Penn State Hershey Children's Miracle Network and Penn State Hershey Children's Hospital.





Mulberry Street Bridge Murals Project

The Mulberry Bridge Street Murals Project is steered by a volunteer committee of dedicated community members who have been working together since 2013 to preserve and relocate murals formerly located on the walls of the Mulberry Street Bridge. The murals were installed 2003-2006. Cesar Viveros, a mural artist from Mexico, and Elody Gyekis, a mural artist from PA, were the artists-in-residence for the spans of murals, which hundreds of students and volunteers helped paint. The committee is currently working with Capital Region Water, Navarro & Wright Consulting Engineers, and the city of Harrisburg to relocate the murals back into the public.
