Emerging Philanthropist Program—Application focus & deadline to be announced in Spring 2020

Eligible applicants must have 501c3 status, utilize a fiscal sponsor with 501c3 status, or demonstrate nonprofit status as a church, school, or similar entity. Applicants may apply to multiple grant opportunities, but may not submit more than one grant to each opportunity. Application may begin at any time during the open application period. TFEC grantmaking does not fund advertising, capital campaigns, direct lobbying to influence legislation, individuals, religious organizations for the propagation of religious doctrine, or retroactive projects. TFEC believes that all voices are vital for our region's future. We promote equity and embrace the diversity of individuals, ideas, and expressions.
