Serving and strengthening the community by providing emergency shelter, resources and supportive services to individuals and families experiencing homelessness.

Organization History: Do not exceed this page

Community CARES has been in service for over 15 years. In 2004 members of a local church recognized the problem of homelessness locally and were compelled to take action. Soon after, other churches joined in opening their doors to the area's homeless. In 2009, CARES became a 501(c) 3 nonprofit organization and today provides outreach, coordinated entry, emergency overnight shelter, resources and supportive services to single women, men and families at risk of or experiencing homelessness in Cumberland County, 365 days a year.

Community CARES is a 501(c)3 public charity which operates several programs, all focused on assisting people at risk of or experiencing homelessness. Hosted by local area churches which rotate monthly, the shelters provide overnight emergency shelter for those individuals and families experiencing homelessness. *Cumberland Street Reach* is a mobile outreach program designed to engage, assess and combat homelessness for individuals and families who are at risk of losing their home and those living on the streets, in encampments and in locations not intended for human habitation, throughout Cumberland County. The Resource Center is the hub of our daytime operations for both staff and residents. Here, residents receive supportive services and access to other necessary basic needs including a place to do laundry, take showers, receive mail, make phone calls, access computer technology, cook meals, and rest when they are ill or working nights. Residents meet weekly with a Supportive Service Coordinator to develop housing plans and strategies to overcome some of the unique barriers they face as they work toward stability and independence.

Community CARES received a \$500 grant for the Youth Emergency Shelter program in 2019 (to be used in 2020). Unaccompanied homeless youth are a vulnerable population in Cumberland County, with many of them exiting the foster system or mental health facilities. These grant funds have been used to help support the cost to provide emergency shelter, supportive services and resources to youth between the ages of 18-24 during 2020. YTD through 6/30/20, we have provided emergency shelter and resources to 41 youth.

PROJECT SNAPSHOT

1. Capture your project and the community need it seeks to address in 200 words or less.

The Youth Emergency Shelter Program seeks to address the community issue of homeless youth by coordinating emergency overnight shelter along with resources and supportive services for youth between the ages of 18-24. According to the National Resource Center on Domestic Violence, homeless youth is defined as "unaccompanied individuals ages 12 to 24 without family support who are living in shelters, on the streets, cars, vacant buildings or who are couch surfing." https://www.acf.hhs.gov/fysb/resource/dv-homelessness-stats-2016.

The Youth Emergency Shelter is a Community CARES program that addresses the needs of youth ages 18-24 who are experiencing homelessness and seeking shelter in Cumberland County, 365 days a year. CARES staff coordinates this program as they work to ensure the safety and well-being of the residents while they navigate their way to overcoming homelessness. They make sure the shelter locations are available and ready each night and arrange for transportation (on the CARES bus) to and from the shelter twice daily. They assist the residents in overcoming their barriers to homelessness, including providing case management to establish housing plans and goals, obtain housing and jobs, and access other community supports as needed.

Homelessness is a health crisis and continues to be a concern in Cumberland County. According to the National Alliance to End Homelessness (NAEH) 2019 point in time count, on a given night, 35,038 unaccompanied youth were counted as homeless in the United States, with 89% of those falling between the ages of 18-24. Even more staggering is that 50% of those youth between the ages of 18-24 are unsheltered, sleeping outside, in a car or in another area not intended for human habitation www.NAEH.org. According to research by JAMA Internal Medicine, "homeless individuals who live and sleep on park benches, in the corners of alleyways and under bridges are three times more likely to die than those who live in shelters and ten times more likely to die than the general population."

Our target population for this grant funding will include individuals between the ages of 18-24 who are seeking Emergency shelter, supports and resources throughout Cumberland County. Community CARES operates in accordance with Continuum of Care (CoC) priorities, which include chronically homeless, veterans, families with children, and unaccompanied youth.

Community CARES Emergency Shelter serves youth ages 18-24, who are experiencing homelessness and seeking shelter in Cumberland County (365 days a year). CARES provides a place where the individuals are safely off the streets when they have no other place to go for the basic need of shelter, while getting the necessary support needed as they work to overcome homelessness and getting the necessary rest needed to perform well in school and at jobs. Often these youth have aged out of foster care or have no family support systems and many do not have high school diplomas. Often these youth have young children of their own, who are at risk of being removed from their parents if stability is not maintained. Community CARES also advocates for the minor children of the youth in our care by collaborating with local schools and human service agencies. Community CARES works with Children and Youth Services and other related agencies as needed to advocate for the health and well-being of the children. This collaboration is essential to best serve our clients and their needs as we support the entire family unit.

72 and 41 youth have actively received supports through Community CARES Emergency Shelter during 2019 and YTD 2020 (through 6/30/20) respectively. Many others have been assisted through Cumberland Street Reach (some have been referred to CARES' emergency shelter through this outreach program). The continued identification of unsheltered homeless youth demonstrates the need for emergency shelter services, as well as street outreach for individuals who are unable or unwilling to access shelter.

These youth often struggle with common barriers causing homelessness, including domestic violence, lack of affordable housing, mental health and addiction issues, unemployment or low wages, poor or incomplete education, etc. While residents are in our program, they receive help from Supportive Services Coordinators who help them to develop housing plans, establish goals and direct them towards additional supports and human services necessary to help overcome homelessness and the barriers that contribute to it. A goal is to assist them in gaining independence as they seek employment, work on life skills and strive toward the goal of placement into permanent housing. The impact to the individuals receiving these services is to help provide long term solutions to poverty by equipping them with skills needed for independence and healthy, stable lives.

With the onset of COVID-19 and its trickle effects, we are seeing an increase in the number of inquiries and calls from youth seeking supports. We anticipate this need to grow as the effects of COVID-19 continue to unfold. Many youth who never imagined homelessness as a reality may begin to find themselves in financial crises as a result of the impacts of COVID-19. Unemployment, reduction in wages and/or hours and the market decline as well as increases in domestic violence and addictions and other family issues are all circumstances that could lead a youth to housing insecurity and the need for assistance. As eviction moratoriums are lifted in the coming months, we expect the need for our services to be even greater.

During the COVID-19 pandemic, our doors have remained open 24 hours a day to meet the needs that we have always supported and to provide additional resources as we are able. Since many other local human service agencies have temporarily closed or limited their resources during this time, we have increased our services to meet some of the needs normally provided by them (including outdoor restrooms, hand washing stations, access to showers, etc.). We have referred households to local food banks and provided many with basic necessities. In addition, we have helped coordinate (and where available fund) short term hotels for households with no other place to go to shelter in place. Finally, our generous community has provided a daily hot meal for our shelter residents since March.

We screen numerous calls daily from institutions like prisons, behavioral health facilities, nursing homes and hospitals desperate for help securing housing for those in their care as well as from individuals and families seeking supports and services. We have worked to divert many to alternative options in place of homelessness, while enrolling others in our Emergency Shelter program. Many of these people needed a live person to help them through their situations and we find ourselves assisting with many unique situations as a result of the impacts of COVID-19. This growing need for resources supports that our services are vital now more than ever, and we are committed to keep building our resources to remain a source of hope for many.

As we continue to realize the effects of COVID-19, our community will need to partner together to provide support to the most vulnerable populations including unsheltered youth. COVID-19 will have lasting impacts on the youth of our community for the foreseeable future and efforts to mitigate these effects by providing supports through Emergency Shelter will be important in helping in the recovery.

Grant funds will be used to help offset the operating costs of the Youth Emergency Shelter program, including the cost of late arrival cell phones, transportation by Community CARES bus to and from the shelter (including fuel, insurance and maintenance), and support for Community CARES staff who partner with the individuals as they work toward overcoming homelessness. Staff not only ensures the logistics of the overnight program, but also works during the day to assist the youth with the challenges they face in their daily lives. The work with them to develop housing plans, secure employment and access other community resources.

The Youth Emergency Shelter is an ongoing program that takes place 365 days a year in our Emergency Shelter, located in Carlisle, PA. This program is supported by our Resource (day) Center located in Varlisle, PA and Cumberland Street Reach (mobile outreach throughout Cumberland County). All dates and locations are confirmed for 2021.

Although we work in conjunction with many local human services agencies (referrals for services, etc.) to ensure the best possible success for those we assist, we do not require a partnership or collaboration to ensure the ongoing success and viability of this program. The Youth Emergency Shelter program serves a need in Cumberland County (and does not duplicate a need) independent of any other organization.

Community CARES is committed to the Youth Emergency Shelter program and will continue to fully operate this program, in the event the proposal is not funded at the level requested, by seeking and committing additional funding sources including contributions, grants and fundraising dollars.

We are requesting TFEC funding in the amount of \$1,000 to assist with the costs of the Youth Emergency Shelter program. Other funding sources will include community contributions, fundraising and grants.

Community CARES ended 2019 with a budget surplus of \$83,695. Approximately \$58,000 came from grants awarded and received in 2019, designated for specific projects to be completed during 2020. Any additional surplus will be saved in reserve to obtain a permanent overnight shelter location/day center facility.

Community CARES serves those experiencing homelessness and seeking shelter in Cumberland County, as an overnight Emergency Homeless Shelter, and offers our residents access to a daytime Resource Center that provides a kitchen, laundry room, bathroom/showers, lockers, computer technology, internet, a mailing address, telephone, wellness rooms and a community gathering area. The Resource Center is also a point of contact for residents to meet with Supportive Services Coordinators to develop plans for overcoming homelessness. In addition, for those who are not eligible for emergency shelter (i.e. Megan's law offenders, individuals with history of violent crimes, etc.) or those who choose not to enter emergency shelter, Cumberland Street Reach (street outreach) offers services to anyone who is homeless or at risk of homelessness throughout Cumberland County, meeting people right where they are located. These services are available to men, women, and families. Community CARES offers an environment of inclusion by a non-discrimination policy with regard to any protected class, including age, gender identity, race, ethnicity, national origin, range of disabilities, sexual orientation and socio-economic status. We make all aspects of our program accessible to all individuals who otherwise qualify for our programs, to the best of our ability. Our Resource Center is accessible and our bus has a lift to accommodate a wheel chair and/or residents who are not able to do steps, as they travel to and from the shelters each night.
