I have always been interested in biology, with my favorite concentration being genetics. The structure of genes and its encoded information embodies all organic life on this planet, while also expressing the differences of species and the individuality within a species. My interest in this scientific field had greatly expanded due to the discovery of gene-editing tools like CRISPR and CAS9, which have opened the door to cheaper and more effective gene-editing processes that could revolutionize medicine and pharmaceutical development. I want to be a part of that research and help develop newer inexpensive pathways for medical compounds or the development of new medical treatments using gene-editing tools or GMOs.

For me to achieve my dream of working with these new tools, it is essential that I get a post-secondary education. Not only to get a more advanced understanding of genetics and other concepts like biochemistry, but also to work directly with these new tools in the laboratory and through research opportunities. Elizabethtown College has already proven to be a good choice for an undergraduate education since it has well-equipped laboratories and has introduced a new CRISPER experiment taught through the genetics class. This institution also has many research opportunities on and off campus. Overall a post-secondary education is necessary for me to learn how to use these new tools, and to be able to do legitimate research using these tools which will greatly expand my knowledge and help improve my career opportunities for the future.
