The mission of Farm of Hope Inc. is to provide adults who have intellectual and developmental disabilities and Autism a meaningful day through joyful group activities on a family farm setting and in our community.

Organization History (Do not exceed this page)

In 2005, Nina and Neil Rovner purchased 17 acres, including a barn, a 1600-square-foot garage, and a farmhouse, with the intent of creating a much-needed day program for their adult daughter with special needs. Hope Springs Farm has expanded to include therapeutic animal care, horticulture, experiential learning, and several community-based volunteer, education, and recreational programs. We now have a staff of 36 highly specialized professionals supporting 60 program participants daily, and serve approximately two dozen non-profits in the region. We incorporated as a 501c3 in 2016.

PROJECT SNAPSHOT

1. Capture your UPstream project and the community need it seeks to address in 200 words or less.

The Pathways to Pasture Project will create new paved walkways into the pastures enabling those with specialized equipment (walkers, wheelchairs, etc.) safe and easy access to the animals and gardens, and reconfigure and construct our driveway and parking lots to establish a protected and efficient entry and exit to the farm as well as greater parking capacity.

"Everyone deserves to live a life of meaning." The adults that attend at Hope Springs Farm (referred to as "Growers") come to us with challenges unique to each individual, presenting obstacles that can keep someone from participating in community activities and consistently making a meaningful contribution to society. At the Farm, we purposefully maximize Growers' abilities through essential farm chores, hands-on experiential learning activities, community volunteerism, and social recreation designed to help each Grower achieve their individual goals.

By increasing access to the core of our inclusive program, we create positive change by addressing several obstacles at their source: providing safe and passable routes into our pastures and pens, preventing potential accidents and safety issues at entry and exits to the farm for parents, providers, and transportation companies, and expanding our parking to accommodate a growing community transportation fleet, visitors, and staff.

The Farm of Hope "community" is multi-fold – it includes our Growers (adults with intellectual or developmental disabilities, or Autism), their families and care providers, our staff and volunteers, and the residents and business of Dauphin, Cumberland, Perry, Lebanon, Berks, and Lancaster Counties. The Farm has been active for over 13 years, but over the past few years, we have focused our efforts on finding ways for our Growers to be active, continuing members to the community at large. A substantial part of this effort has involved bringing the Growers out into the community through several successful volunteer programs. We currently send between six and eight vans with Growers and staff to various area non-profits where they participate fully in the jobs and activities needed to keep those organizations active and growing. One key result of these programs is that the greater population has become more familiar with and more accepting of adults with special needs. By interacting regularly and in familiar environments with a wide variety of businesses and organizations, the wall that sometimes separates our Growers has begun to crumble. Our Growers are no longer as isolated, and are experiencing the joy of being purposeful and impactful members of society.

With the Pathways to Pasture Project, we proactively build on this momentum by bringing people TO Hope Springs Farm. Our neighbors have seen us in the community – now it is time for them to come and see us, see our environment and the wonderful work we are doing on the Farm. It is important for the public to experience the therapeutic effects of feeding, cleaning, and caring for a variety of farm animals. It is eye-opening for them to taste the vegetables and fruits from our gardens, to enjoy the beauty of our flowers and plants, and to touch and feel the items produced in our art and woodworking studios. Finally, it is so important that the general public have a chance to join us in a yoga or music therapy class, in painting murals on the new barn wall, in singing at our holiday sing, and in preparing the grounds for another season in the Spring.

This project is "Upstream" because it looks to the future, anticipates potential obstacles and eliminates them, providing a safe, welcoming, and accessible environment for all. By increasing access to the core of our inclusive program, we create positive change, addressing several obstacles at their source: providing safe and passable routes into our pastures and pens, preventing potential accidents and safety issues at entry and exits to the Farm, and expanding our parking to accommodate a growing community transportation fleet, visitors, and staff. Our geographic area are the six counties we serve; the audience is the extended "Hope Springs Farm" community. Grant funds will be used in Phase Two of the project to:

- 1. Excavate the existing parking area and driveway.
- 2. Reconfigure and excavate three new walkways into the remote pasture areas, a U-shaped drop-off driveway, and new vehicle parking areas, and to prepare for new asphalt.
- 3. Install binder and wearing.
- 4. Paint parking and handicap lines as needed.
- 5. Clean up and disposal.
- 6. Stormwater management construction, to include installing a drain and catch basin, digging a trench a trench to the existing retention berm, increasing the size of the berm if necessary to ensure appropriate stormwater drainage.

DATES & LOCATIONS

Excavation, construction, and paving (all taking place at 201 Trail Road, Hershey PA) is to be completed during the spring of 2021. This timeline includes storm water construction (installation of a larger berm and other environmental accommodations). Exact dates for these phases have not been confirmed due to COVID-19 delays in the industry; however, we are in constant contact with the vendors and and engineering firm. Each subphase of this process takes approximately 45 days, so a total of 150-180 days is necessary to complete this portion of the project.

The next phase – any additionally required construction and environmental improvements such as grove planting, etc. – will proceed during the summer and fall of 2021, with a start date dependent upon the current delay impact, and the need for appropriate timing for planting in this region.

ASSESSMENT & IMPACT

- **6a.** What will project success look like? Provide a brief overview of the project's key outcomes, outputs, and/or other results of success.
 - Increase in the number and type of Growers to which we can provide therapeutic animal intervention. The "Pathways to Pasture" Project extends those paths well *into* the pastures and creates "landing pads" where wheelchairs and other adaptive equipment can be stabilized. This initiative will allow us to invite potential Growers requiring specialized equipment to our program, and the pastures and animals will be exponentially more accessible for everyone. The care farm component of Hope Springs Farm's program is personal, warm, and *uniquely reciprocal* when compared to a traditional therapeutic healthcare settings. With support and guidance, the Growers complete daily agricultural and animal care tasks that facilitate a profound impact on overall behavioral and cognitive functioning. These foundational programs provide growth, emotional security, and happiness for the Growers, who communicate their sense of purpose to their own families as well as the community at large.
 - Increased safety and improved access for Growers, staff, visitors, and volunteers.
 - Greater parking capacity allowing an increase in the number of volunteers and visitors to the Farm, and
 additional space for our own fleet. This also prevents traffic tie-ups on Trail Road and the contiguous streets;
 and improved relationships with neighbors potentially impacted by traffic snarls as the volume of access to
 our facilities increases.

We will measure success for this project in several ways:

- 1. Completion of multiple paved pathways and landing pads in the pastures and gardens.
- 2. Completion of stormwater management construction (per regulations) in order to reconfigure our parking and driveway.
- 3. Completion of new circular driveway and larger parking lot.
- 4. Formal and informal surveys of regular users of our facilities, including staff, providers, transportation companies, and families; with these we will measure the level of satisfaction that Growers are safely dropped of

- and picked up and whether we have prevented as much traffic congestion as possible with the new configuration.
- 5. We will continue to take photos (before and after) of the grounds as each phase of the project is initiated and completed.
- 6. We will continue to maintain accident reporting and will closely examine data related to the new installation of pathways and vehicle access.
- 7. We will assess whether the new configurations and pasture/animal access has an impact on the number and type of Growers, volunteers, and visitors we are able to accommodate on the Farm.

FUNDING & SUPPORT

- 7. If this proposal is not funded at the level requested, will you be able to implement the project as stated? Explain as needed.
 - We have already raised enough funds to complete the Engineering phase of this project (over \$25,000) and have received funds (\$15,000) and pledges toward the implementation of demolition and construction phases. If this proposal is not funded at the level requested, we will continue to apply for grants and solicit businesses in our area for their support. As a last resort, we may have to take out a loan in order to insure that the work is completed in a timely fashion. Some of the pledges and applications have been delayed as a result of the COVID-19 economic distress.

 - We are requesting \$10,000 against a total need of \$128,430. We have received to date \$40,000 (Donald B. and Dorothy L Stabler Foundation/\$25,000; Dauphin County Local Share Fund/\$15,000), and currently have pending but not yet approved applications (Leo Niessen Jr, Charitable Trust/\$10,000; Fraklin P. and Arthur W. Perdue Foundation/\$5,000). We also will be applying to the Stabler Foundation again this year for continued support for this project.

 - We ended 2019 with a surplus of \$4782 which will be rolled into our operating budget for 2020, as the economics of COVID-19 have cost our organization substantially.

We are writing about Hope Springs Farm's request for an UPStream grant for the Pathways to Pasture project, which we also know as the Land Development project.

Hope Springs Farm is doing amazing work in Dauphin County and making an impact not only here, but in many of the surrounding counties as well. More than simply providing satisfying, rewarding activities and services, our Growers (adults with special needs) are experiencing direct and reciprocal therapies by participating in daily care of a variety of animals. Each morning and afternoon, the Growers are responsible for feeding and caring for the animals, and as a result, each have an important and purposeful role in daily life on the Farm. They take ownership and responsibility for the sheep, pigs, mini horses, goats, chickens, alpacas, and rabbits, and subsequently develop relationships with the animals themselves, as well as with the other Growers through shared experiences with the animals.

This request for funding will help to provide paved pathways so that Growers with mobility issues are able to gain access regularly to the pastures where the animals spend their days. There will be landing pads, so that people with wheelchairs and walkers can stop, relax, communicate, and enjoy the environment around them as a community. These accesses will also allow for a broader spectrum of special needs to be served at the farm, to include those people for whom this equipment is a necessity. Finally, these new pathways will also make the Farm pastures and gardens more available for visitors to the Farm – people who visit, volunteer, and partake in the many activities open to the public each season.

These programs are so important to the social, emotional, and physical development of these adults, and to our knowledge, do not exist anywhere else in our region. It is imperative that no one is prohibited from participating. This project makes that possible.

Please seriously consider this grant request. As parents of a Grower, we know firsthand the weight of the differences made by this special place. We can only imagine how much better it will be in the future when more people have the opportunity to be part of this wonderful experience.

As the care provider of an adult with special needs, I can attest to the unique and immense my family member realizes as a Grower. Access to the Farm facilities -- and in particular the animals -is a key component of the therapeutic and community-building experience she enjoys.

Hope Springs Farm is always looking for ways to improve their programs, and to proactively provide greater breadth and depth, not only to the current Growers, but to future participants and the community at large. To that end, Jim Gainer and the staff have completed an engineering study as the first toward expanding the access to the animals (and the horticultural areas of the Farm) by paving that will end with large platforms for people with impeded mobility, so that the pastures are accessible. In addition, they have given a great deal of thought to the increasing number of vehicles that enter and exit the Farm, dropping off/picking up Growers, volunteers, staff, and visitors, and have designed a circular driveway and expanded parking areas so that safety for everyone is ensured. The Farm's own fleet of "community vans" - used to bring the Growers to volunteer opportunities every day - is growing with increased demand for this type of community service. Part of Jim's vision is that their own fleet be parked away from the main house, thereby removing the potential dangers of vehicles in pedestrian space. As I understand it, this is a complicated project in that there are
