#### APPLICANT ORGANIZATION MISSION STATEMENT

The mission of KidsPeace is "to provide hope, help and healing to children, adults and those who love them."

#### PROJECT SNAPSHOT

KidsPeace respectfully requests funding to be used towards enhanced opportunities for foster youth and support for foster parents. Specifically, foster youth will be given opportunities to participate in activities to which many of their peers (who are not involved in the foster care system) have access on a regular basis. Supportive resources will include retention and appreciation activities as well as holiday gifts and activities for the foster youth in care.

#### PROJECT NARRATIVE

Grant funds will be used to provide activities for foster youth and foster families in the Harrisburg region.

The KidsPeace Harrisburg Foster Care & Community Programs (FCCP) office opened in 1990 and primarily works with youth who require therapeutic foster care to ensure their safety. Youth in therapeutic foster care typically have a mental health diagnosis and/or exceptional behavioral needs. KidsPeace trains and licenses foster families, matches foster youth and families and provides casework and treatment support to the youth and families.

In addition, the KidsPeace Harrisburg Foster Care program works with a high percentage of kinship foster homes, in which grandparents, aunts and uncles, other family members or family friends are called upon to provide shelter and care to children who either are or would be in the foster care system. This is known as "kinship care."

Kinship care often occurs unexpectedly, or the process of having the child move into their home progresses at a rapid pace. Kinship caregivers often feel emotionally overwhelmed, their household schedules and daily lives drastically change rapidly and they are faced with legal and systemic challenges with few resources.

KidsPeace staff have found that it is important to communicate appreciation for the work that these families do and the support that they provide the foster youth in their care. KidsPeace seeks to provide family experiences during 2021 for foster families to enjoy. These may include, but not be limited to admission to recreational and entertainment activities and family attractions. With the COVID-19 pandemic continuing at this time, other support may include supplies for families to participate in at-home activities in order to ensure the health and safety of foster youth and families. These activities are even more significant to the youth, as many foster youth do not have the opportunities to participate in activities to which many of their peers, who are not in the child welfare system, have access on a regular basis.

Furthermore, while the holidays are typically a joyful and exciting time of year for most children, they are often more challenging for children in foster care. It can be an emotional time for foster youth, who are often reminded that they are unable to be with their biological families. Although it is a season usually peppered with "traditions," foster children may not have been in a single home long enough to build traditions of their own. In an effort to make the holidays a more special and festive time of year, the local KidsPeace program holds an annual holiday event for the foster children and families. Requested funding will help offset costs for the venue and food (if a group event is allowable in December 2021 based on local health guidance regarding COVID-19), as well as purchase gifts for children and families who receive local KidsPeace services who may be unable to provide them due to financial challenges.

#### **FUNDING**

KidsPeace respectfully requests \$1000 towards the cost of foster family and foster youth activities. KidsPeace seeks grant funding from various sources on a regular basis and pursues appropriate and available funding sources. KidsPeace holds local fundraising activities and requests support from local donors. If the project is not funded in its entirety, KidsPeace will implement the project on a smaller scale within a manageable budget.

#### PROJECT SUCCESS

Success will be measured through the following outcomes:

1. KidsPeace will provide support for family-friendly activities for foster youth and foster families. Activity supplies and/or tickets

- to recreational or entertainment venues will be tracked by KidsPeace staff.
- 2. KidsPeace will purchase and distribute holiday gifts for foster youth receiving care through the KidsPeace Harrisburg FCCP. KidsPeace will request a "wish list" from the foster youth and/or families prior to the 2021 holidays to ensure that gifts are well-matched to the youth's interests.
- 3. KidsPeace will receive feedback on the success of events and activities from foster youth and foster families via a verbal and/or written survey.
