



Governor George Leader was born in York County in 1918. His term as Governor of Pennsylvania in the 1950's was the highlight of his life. He was a champion for those with disabilities as well as education and worked hard to bring about positive change in both areas. Mr. Leader was a man of convictions and was not always right, but when he believed in something he fought to the end to achieve his objective. He started his Leader Nursing Centers in 1962 to provide a better option for senior health care in Pennsylvania. His interest in nursing began with this venture. Mr. Leader was very interested in providing education for Licensed Practical Nurses (LPN's) and employed many of them in his nursing homes.

1. Student Resume: [Click here](#) to download the fill-in Word document that you should complete, save, and attach to your application.
2. FAFSA Student Aid Report (SAR): Please attach the report in its entirety. This report must include the Estimated Family Contribution (EFC). Please be aware that the SAR is **not** the same as the Summary Report. In addition to the SAR, you may also provide a letter with information you believe will be useful in determining your financial need (e.g., family and student income). Are there extenuating circumstances of which we should be aware? For example, illness in the family, loss of employment, or other relevant information?
3. Personal Essay: Describe your interest in nursing. Essay should be titled, 300 words maximum, typewritten, 12 pt. font, double spaced.

The following requirements must be emailed to scholarshipapplications@tfec.org separately. These items will not appear as attachments to your online application or prevent you from submitting:

The following requirements must be emailed by your personal references:

1. *Two (2) Personal Reference Letters.* Letters may be from your advisor or a professor on school letterhead, an employer/manager, community service leader, or any individual who can attest to your readiness and ability to complete the LPN program. Letters from family members will not be accepted. ***All reference letters must remain confidential.***

Your Official Transcript must be mailed or sent as a certified PDF emailed directly from your high school or university.
It is your responsibility to ensure that your transcript is received by the deadline. The transcript ***must be received*** by the deadline, ***not postmarked***.
