#### Happy Summer!

Well the market continues to thrive in the second quarter of the year. While valuations are high, there seems to be only minor volatility and a nice level of confidence in the economy. Our Equity Fund, Model E, returned 8.92% for the first six months of the year. As usual it slightly outpaced its index, which was 8.70% for the first six months.

Similarly our blended fund, Model A, returned 6.88% while its index was 6.78%. Model F, our Fixed Income Fund, earned 2.30% while its index was 2.27%, repeating the experience of a small return in excess of index. So it has been a very good six months for all three of our funds when measured against their indices.

On a sad note, we mourn the loss of Pete Ressler. Pete was a wonderful man and a valued member of our Investment Advisory Committee. His valuable input to our discussions was always welcome and benefitted the contributors and beneficiaries of TFEC over a long time span. Pete will be missed by all of us who had the pleasure of knowing and working with him over the years.

The Investment Advisory Committee met in April and in July. At this time there are no pending changes to our philosophy nor any components of our portfolio. The disciplined approach continues to work as we had expected.



## WORK IN PROGRESS: ADVANCING Community access to early Education through tfec and GHF grantmaking!

The Foundation for Enhancing Communities (TFEC) and Greater Harrisburg Foundation (GHF) are pleased to move forward with the 2016 Strategic Initiative: Phase One—now a Phase Two Initiative!

The mission of The Early Childhood Strategic Initiative is to explore and invest in programs that focus on Kindergarten readiness for children ages 3 to 5-years-old who are not in preschool settings and



may, for multiple reasons, have barriers to accessing those services. To carry out this mission, GHF created two grant opportunities: The Early Childhood Strategic Initiative: Phase One and The Early Childhood Strategic Initiative: Phase Two.

Phase One of the Early Childhood Strategic Initiative consisted of grantmaking to fund pilot research to determine programmatic priorities. Phase Two of the Early Childhood Strategic Initiative is a four year grant that will serve to connect families to early childhood services and resources by ensuring that quality early childhood services and resources exist and are accessible to children and their families, educators, and the greater community.

Within Phase Two of the Early Childhood Strategic Initiative, four grant awards will be made and those awarded grants will receive 4 years of funding: \$25,000 in Year 1; \$15,000 in Year 2; \$10,000 in Year 3; and \$5,000 in Year 4. The GHF Advisory Committee met in May to review the submitted Letters of Intent for the GHF Early Childhood Strategic Initiative: Phase Two. Thirteen Letters of Intent were reviewed and eleven organizations were selected to move forward in this process. Organizations selected to move forward have been invited the complete the GHF Early Childhood Strategic Initiative: Phase Two grant application. The deadline for this grant opportunity is August 1, 2017 and notification of grant awards will be made in Fall 2017. All grant activities must take place during the calendar years (Jan 1-Dec 31) of 2018, 2019, 2020 and 2021. Organizations eligible to apply will serve individuals in the central Pennsylvania counties of Cumberland, Dauphin, Franklin, Lebanon, Perry and the Dillsburg Area or Northern York County. Applicants must either be a registered 501(c)(3) nonprofit organization act as a fiscal sponsor for the proposed project. Eligible projects include, but are not limited to, subsidizing travel costs or childcare costs for parents so families may access childcare that provides early learning; expanding or creating new services or resources to serve more; and creating, improving upon, or increasing access and/or public awareness of a "hub" of childcare services available within a noted region. All proposed activities must be based on the findings of Phase One, and all applicants have consistently been encouraged to focus on the shifts needed to better service their communities.

TFEC and GHF are excited to further their collective commitment to our area communities by advancing access to early education! We are looking forward to fueling additional positive impacts in 2017-2020 and beyond—stay tuned!

The remaining \$2,200 will go to the Emerging Philanthropist Program, funding annual grantmaking and next year's Harrisburg Hoopla event.
