Briefly describe your organization.

A. Mission purpose, and history

RSVP of the Capital Region, Inc. (RSVP) is a volunteer based organization that has been recruiting, training, and placing volunteers in not for profit agencies, schools, government offices, hospitals and senior residences for almost 50 years, starting in 1972. The Mission of RSVP is to provide meaningful volunteer opportunities for persons 55 years of age and older and to provide measurable value to the community. RSVP was established to creatively channel the skills, knowledge, talent, and energy of Pennsylvania seniors into volunteer roles custom tailored to help them transform both their communities and their own lives. At the same time, volunteers are enhanced by the volunteer experience, often garnering valuable improvement to their own physical and emotional well-being.

B. Service population and geographic area served, including demographics

RSVP volunteers serve in a variety of capacities, including but not limited to tutoring and mentoring students, operating food banks, providing Meals on Wheels to seniors, providing friendly visits to nursing homes, and health care fraud education. The volunteers are insured by RSVP, provided with transportation supports if needed, and vetted with criminal background checks and child abuse clearances to help protect the vulnerable populations we serve. Originally volunteers were from the 55 and over population, but as RSVP has evolved over the years so has the corps of volunteers to include volunteers as young as 9 through senior volunteers who are in their late 90's. The service population has a similarly wide range of social and economic demographics. Wealthy retirees of academia, government, and industry are engaged as well as welfare recipients, widows, and wards of the state who never had gainful employment. RSVP is currently serving communities in Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Perry, and York Counties.

C. Current programs, activities, and accomplishments

RSVP works in collaboration with other not for profit agencies, government offices, and schools called 'stations' collectively to make a positive impact on communities. Currently, there are over 150 stations in our 8 county service area and each of them have unique, and oftentimes multiple, needs we work collaboratively to address. These programs and activities are too various and numerous to list en masse but the following describes a few of the service activities and programs that pertain to this funding request. RSVP offers cross-generational math and literacy development to all of its partner School Districts through the America Reads and America Counts initiatives supported by the Corporation for National and Community Service, our federal sponsor. Additional cross-generational opportunities for youth development managed by RSVP with collaborators include Pre-K and Head Start programming in Cumberland, Dauphin, Lancaster and Lebanon Counties, and After School and summer enrichment programming in Cumberland, Dauphin, Lancaster, Lebanon, Newport, and York counties.

In 2012, the Steelton Highspire School District implemented RSVP's "Garden of Youth" (GoY) mentoring program in addition to the tutoring services that engendered the organizational partnership. The Garden of Youth is a cross generational mentoring program that offers social and academic support (mentoring) at no cost to students in resource-stressed communities of the Capital Region. Garden of Youth activities are administered in an after school club fashion,

are entirely hands-on and center on student engagement, community service, and agricultural edification. The program uses the leadership and experience of RSVP volunteers to assist middle school student participants in the development of knowledge, skills, and activities that increase student achievement, enhance personal growth and produce agricultural products. On site, students work with Garden of Youth mentors to maintain a school garden. Occasionally, the participants visit local farms to learn about mass production of agricultural products and to glean produce for community service. The gleaned produce and excess produce grown on-site are donated to the Central Pennsylvania Foodbank for community service.

In 2017, the Summer Fruit and Fun program was initiated in Lebanon City. The program is a mobile marketplace that brings fun-filled nutritional programs and fresh produce to under privileged children at various Lebanon city playgrounds, the YMCA, Salvation Army summer camps, and Intermediate Unit classrooms. For underprivileged children, summer can be a difficult time in terms of learning and lunch. Being out of school in the summer months coincidentally means they are out of the meal(s) or backpack programs provided during the school year. The Fruit and Fun mobile produce program delivers fresh fruit and vegetables to the targeted audience for supplemental sustenance and provides games, activities and recipes that will teach the children tips on healthy eating and summer-time fruit snacking. The Summer Fruit and Fun program is developing successfully in Lebanon City. Since its inception, support for and participation in the program has nearly doubled.

In 2019, RSVP delivered the Dauphin County rendition of the Fruit and Fun program in the Steelton Highspire School District with Children's Home Fund support. The program was engendered to retain student participation in the Garden of Youth and provide healthy snacks and nutritional edutainment to K-6 summer enrichment program participants. The summer enrichment program was administered by the Salvation Army. The Fruit and Fun program was so well received the Salvation Army requested the service for their 2019-2020 after school program. RSVP did not have the budget to accommodate that request and agreed to pursue it for the 2020 summer and 2020-2021 school year. Children's Home funding supported the request for additional programming and RSVP was able to extend Agricultural and Environmental enrichment to 2019-2020 After School program participants. The provision of healthy whole food snacks via the mobile produce program however was unable to be included.

RSVP works in partnership with schools and/or School Districts to fill unmet or newly identified needs while utilizing school based facilities and equipment to lessen program costs. The partnerships enable RSVP to minimize the administrative undertaking and dollar amounts needed for the School Districts to provide the services.

Briefly describe the project for which you are requesting funding:

A. Project goals, objectives, and planned activities/events

The requested funds will be used to administer the Fruit and Fun Extended program for students in the Steelton Highspire School District enrolled in the Salvation Army's summer and after school programs. As in the current Fruit and Fun program, RSVP volunteers will continue to work with Garden of Youth students to prepare the fresh fruit and fun filled goody bags and deliver them to the student participants. Programming will be administered for 4 consecutive weeks during the summer and once per month during the after school program year. Volunteers will also provide a brief overview of the goody bag's contents and nutritional value of

the selected fruit. Other than fruit, the goody bags will contain activity packets with games, nutritional literature, and recipes that will teach the children tips on healthy eating and summertime fruit snacking. RSVP will obtain nutritional literature and fun-filled items through the Central Penn Food Bank and partner with Strite's Family Orchard to secure the produce and promote locally produced food and farming. RSVP will work with the SHSD, Strite's family and the Salvation Army to end the program year with a family event that promotes healthy whole food and teaches parents about its's social, behavioral, and nutritional benefits.

B. Project timetable and budget; separate from organizational budget

The Fruit and Fun Extended program is scheduled to begin in February 2021 and be administered once per month through June, for 4 consecutive weeks over July/August, and once per month again from September through November. RSVP is requesting \$6,480 out of a total program budget of \$8,603 to provide for the purchase of the fruit, contents of the goody bag, the mobile food service provider, and field trips to Strite's Family Orchard. Partial funding for administrative and volunteer support is also included in this funding request. Already secured are agreements to use any classrooms, the cafeteria, school facilities, and outdoor spaces within the SHSD; and coverage of basic audit and insurance costs under RSVP's existing Corporation for National and Community Service grant. An itemized budget (separate from the organizational budget) is attached.

C. Constituency served or target population

The Steelton-Highspire School District (SHSD) is an urban public school district located in Dauphin County, Pennsylvania. It encompasses the boroughs of Steelton and Highspire, both industrial suburbs of the City of Harrisburg. The average SHSD family income is \$34,000 per year. 83.4% of the student population is economically disadvantaged and the District is 100% eligible for universal (free) breakfast and lunch due to the depressed economic status of the community. In 2016-17, SHSD spent 29.9% below the estimated funding adequacy target needed to properly educate all its students (PA Partnerships for Children, 2018). Additionally, the communities within SHSD are in "food deserts," which are characterized by lack of access to healthy foods. Lack of access to nutritious food and attending school while hungry both impact healthy youth development, cognitive development, emotion and behavior regulation, each detracting from youths' ability to succeed in school.

E. Project benefits and anticipated results

The intended benefits of the Fruit and Fun project are increased awareness of and access to fresh whole foods via sustained participation in School District projects that provide and promote whole food consumption. The benefits of whole food consumption are many and range between fighting hunger to fighting cancer. The anticipated result of the program is greater retention of students participating in one of the projects the District offers to provide the intended benefits.

F. Description of how project differs from similar projects in geographic area served

RSVP is not familiar with any other projects similar to the Fruit and Fun Program operating in the SHSD area. However, as mentioned above, RSVP offers a Fruit and Fun project in Lebanon City that utilizes "mobile marketplace" of a fruit delivery truck to bring fun-filled nutritional programs and fresh produce to children at various Lebanon city playgrounds, the YMCA, Salvation Army summer camps, and Intermediate Unit classrooms. This program takes a broader approach to program participation, engages greater numbers of children and is the standard to which the proposed program aspires. The proposed program in SHSD takes a more targeted approach to program participation and intends to grow within the targeted audience using the program model of Fruit and Fun as it is offered in Lebanon City, but *Extended* throughout the school year.
