I am entering the fall semester as a health professions major. I plan on attending nursing school after I graduate college, however, things may change during my plans. With that being said, having a broad major like that is important as I will still be able to land a career in the health field. Regarding the diversity, I grew up in a community full of minorities so it is ideal to me that I enter a space where I feel comfortable.
