In celebration of its 100th anniversary in 2020, and the future to come, The Foundation for Enhancing Communities (TFEC) is pleased to announce a Centennial Art Contest open to any 6th – 12th grade student(s) in Cumberland, Dauphin, Franklin, Lebanon, Perry, Counties, and the Dillsburg Area of York County.

As the 18th oldest community foundation in the United States, TFEC is pleased to look forward to our communities' next 100 years, and is pleased to ask students to create a visual art image that expresses:

### ELIGIBILITY

- Eligible participants must be a student in 6th-12th grade(s) in Cumberland, Dauphin, Franklin, Lebanon, or Perry County, or the Dillsburg Area of York County at the time of submission.
- Participants must complete and provide the Centennial Art Contest Submission Form and Centennial Art Contest Entry and Release Form with their original piece and submit to TFEC via mail or hand delivery on or by 4pm on October 1, 2020. Submissions must be received on or by, or postmarked by, October 1, 2020.

## RULES

- Each participant may submit one piece of art.
- Eligible mediums include 2-D imagery in pen, ink, pencil, markers, paints, charcoal, watercolors, acrylics, printing ink, and photography.
- Sculpture, collage, and paintings on stretched canvas are not eligible for this opportunity. Painting on canvas panels, unstretched canvas, or other flat surfaces are eligible.
- A template for the submission size is provided on the Centennial Art Contest Submission Form. Submissions may be drawn directly within the provided template on the Centennial Art Contest Submission Form OR artwork may be created in the size of the template and attached to the Form. All imagery submitted is limited to the size provided in the template on the Centennial Art Contest Submission Form but may be created on another surface and attached. If using a white border, the imagery inside the white border must be the same size as the provided template. The template is 4.25" x 5.5".
- Submissions may be monochromatic or full color.
- Do not frame or shrink-wrap imagery. Do not staple submissions.
- Artwork must speak to the theme, "What You Hope Your Community Will Look Like In The Future" and may depict any imagery as long as the imagery does not violate school policy.
- Each participant must complete and submit the Centennial Art Contest Submission Form AND Centennial Art Contest Entry and Release Form.

## PRIZES

- Each winning artist will receive \$1,000 for the Art Department of their school (or school of origin).
- Twelve images will be selected as winners.
- Each school (or school of origin) will be limited to one winner.
- The artwork of the winning artist will be featured by TFEC within its 2021 promotions and will be printed in a series of greeting cards to be sold to the community. All proceeds from these sales will benefit TFEC's area communities for years to come through a fund called, "The Fund for The Future".
- The image of the winning artist(s) and their artwork may be featured in the TFEC Annual Report, newsletter, website, and/or other media outlets.



## Centennial Art Contest Rules

The Foundation for Enhancing Communities (“TFEC”) is holding an art contest to promote its centennial celebration. To participate in the contest, the submitted art piece(s) must be accompanied by the signed entry/release form. By completing the entry form and submitting the art piece(s), entrants are agreeing to the terms of the contest and release set forth herein. Art pieces not accompanied by the Entry and Release Form will not be eligible to enter the contest.

### Contest Rules:

1. Each piece must be the sole property of the entrant artist, or in the case of multiple owners, all owners must be reflected on the entry form with their corresponding signatures. If there are any disputes as to the ownership of the submitted art, TFEC will not undertake to determine proper ownership and the piece will be disqualified.
2. If the piece(s) contains any material or elements which are not owned by the entrant and which are subject to the rights of third parties, the entrant is responsible for obtaining the necessary releases from the third party. Copies of those releases must be provided upon request to TFEC. Failure to procure or produce the necessary releases will result in the piece(s) being disqualified from the contest.
3. Entrant must not have assigned any of rights associated with the piece(s) to any third party and have sole, complete, and unrestricted authority to enter into this release and to grant the rights described in this release. Entrant artist will retain all ownership rights to the piece(s) not licensed to TFEC by entering this contest.
4. By entering this contest, entrant grants a royalty-free, global, irrevocable, perpetual, non-exclusive license to use the piece(s) for any purpose, including publicity, illustration, advertising, and promotion. This license includes the reproduction, distribution, use, reuse, publication, and/or republication in whole or in part, individually or in conjunction with other photos or images, in any medium. The license includes use of the piece(s) in publications, trade magazines, public display, and/or website display in conjunction with the entrant artist’s name.
5. Display of the piece(s) does not necessarily mean that the piece(s) was selected as the winner of the contest.

6. TFEC reserves the right to disqualify any piece(s), which in the sole judgment of TFEC, are inappropriate, in poor taste, or which may have the appearance of being forged, copied, stolen, illegal, or otherwise suspect.
7. TFEC assumes no responsibility for any error, omission, deletion, delay, technical malfunction, theft, or destruction of any contest entry.
8. Entries must be submitted by October 1, 2020. The judges appointed by the Project are not professional judges and are evaluating the piece(s) on their impressions of artistic creativity. The decision of the judges is final.
