The Student Author Movement, a project under The Foundation for Enhancing Communities (501C3), provides free author visits to Title 1 elementary schools. Title 1 schools have large concentrations of low-income students and receive supplemental funds to assist in meeting student's educational goals. The Student Author Movement goal is to help bridge the achievement gap, graduation rate and college entry, using interactive techniques to engage students using writing exercises, illustrating and book publishing as its mentoring tools.

The Student Author Movement is a step towards success for these students. To support and celebrate creativity, illustration and writing, a successful children's book author will visit Title 1 schools to host extensive workshops for up to 200 students per school. The goal is to inspire students by demonstrating how hard work and creativity can pave the path for a successful education and possibly a career in writing or journalism.

We will contact the school, setup the workshop day, travel to the school and conduct the sessions. The classes will receive as many as 50 already published children's books for their personal use and / or the school library. One creative and motivated student will be invited to draft a children's book of their own that could be edited, and possibly published.

COVID PLAN

We realize that with COVID19 many schools many avoid outstide visitors. To overcome this we have already invested in remote video equipment so we can conduct the entire workshop in a virtual situation. If schools are open to visits, we will abide by any and all COVID protocols including COVID testing of authors visiting the schools. We will conduct the remainder of program as normal, distributing books and selecting one student, and publishing their book.

The Student Author Movement, a project under The Foundation for Enhancing Communities (501C3), provides free author visits to Title 1 schools. Title 1 schools have large concentrations of low-income students and receive supplemental funds to assist in meeting student's educational goals. The classes will receive as many as 30 published children's books for their library. Furthermore, one creative and motivated student will be invited to draft a children's book of their own that will then be edited for possible publication. Each visit will consist of this agenda

Introduction

Cover background of the author, and the education process of writing, illustrating, and publishing.

Book origin

A personal story of a young student author, going from writing poems, to short stories, to eventually a complete book, while still only being 12 years old.

How illustrations are born

Show students how to move from "stick figures" to a complete illustration.

Perseverance

Some personal stories on how it takes many failures to eventually be successful.

InstaART

Allows the student to move from a simple sketch to a true piece of art by explaining how to draw a character (torso, head, front, legs, tail, and then a background).

Flash Fiction

A writing exercise to allow the student to quickly see how they can create a short story of their own.

Grant funds will be used to cover the cost of the children's book distributed to the students.

Our two key feedback measures are the teacher feedback scores and the publishing of an individual student book. At past schools, when the student book is published, the school usually has a celebration, and invites local news crews to document the celebration. There clearly sends a signal to every student of the merits of hard work and the impact on their life. For the schools year 2019-2020 Schools visted: 19 Student Impacted: 3037 Student Authored Books Distributed: 83 Teacher Satisfaction Score: 98.7% Student Level of Excitement: 95.3%.

 - Yes, we estimated the cost per school visit to be \$500, so our submission is for 5 visits. Any funding less than \$2,500 will reduce the number of visits, but the project will still proceed

Thank you, First National Bank, for bringing in Stephen Kozan from the Student Author Movement. The students at Fink Elementary loved every second of the engaging and hands- on presentation. It was truly one of the best author visits our students have ever experienced. It epitomized what we strive to do every day in our school.

Fink elementary is a very small community school that with many low- income families, students for whom English is not their first language, and several trauma- informed classrooms that serve the neediest students in our district. Many of our students are reluctant readers and writers, but Stephen allowed students to use their imaginations and become involved in the writing process.

Students felt automatic buy in when they were involved with the "insta-art" process and saw the artist create their idea within minutes. They were also empowered by the novels written by students around the country (and some locally) that were of similar age. Students were very excited to receive these books in their classroom.

A 5th grade teacher commented, "Thank you for organizing and hosting the author visit yesterday. I've never seen the kids so motivated to write and they came in this morning with their faces in the books that he gave us." Many other staff members have also reached out to share their students' excitement of writing. We were all very excited to see students writing, but also, sharing ideas and collaborating together through writing.

We are extremely grateful for Stephen Kozan and Tony Maulfair for bringing this opportunity to Fink Elementary and First National Bank for funding the program. We are very excited for any follow ups!

I am an elementary librarian for Central Dauphin School District, and Stephen reached out to me at the beginning of the school year to come and present at my schools. I had to regretfully turn him down due to lack of funding for community speakers. Stephen graciously responded that he could visit my Title 1 schools free of charge, due to grant through his Student Author Movement. This wonderful program is funded by PPL Electric Utilities. This electric company is equipped with a wonderful outreach department. As a classroom teacher, I had them come (free of charge) to my school to teach the students about energy conservation. PPL provided each student with an energy kit, along with a small grant for classroom supplies. The financial support of Stephen's Student Author Movement is just another example of PPL Utilities commitment providing students with amazing opportunities outside the classroom.

Stephen visited Lawnton Elementary on September 26. Just having an author visit, the students weren't overly excited to sit through another presentation. I promised grades 3-5 that this would be more engaging than the other visitors, and it certainly didn't disappoint. Stephen had 90 percent of the students enthralled in the first five minutes of his presentation. The Insta-Art had all the students at the edge of their seats, and by the time Stephen reached the Flash Fiction, even the most reluctant writers were jotting something down.

The fact that Stephen is providing an opportunity for one aspiring author from each school visit to publish a book is unbelievable. The afternoon of the presentation, I heard students talking about their story ideas, and hoping they would be selected as a finalist. Again, these were not the students who are considered wordsmiths and walking around with journals-these were the "I hate everything about writing" crowd. Stephen Kozan brings an animated, engaging and entertaining presentation to your school, and leaves behind an energy and enthusiasm which encourages students to let their creative juices flow.

2019 Annual Report Student Author Movement

Mission

The Student Author Movement (www.studentauthormovement.org), a project under The Foundation for Enhancing Communities (TFEC), fiscal sponsor, provides free author visits to Title 1 schools. Title 1 schools have large concentrations of low-income students and receive supplemental funds to assist in meeting student's educational goals. Very many Title 1 schools struggle getting funds to obtain outside professionals to mentor groups of students.



Results

In 2019 we were proud to announce the start of our grant soliciting program. It was a huge success. We obtained grants of \$18,000 from six unique companies or foundations. We have another 8 grant applications pending a decision.

Grants

We received grants from:

- First Non-Profit Foundation
- PPL Foundation
- TE Connectivity Foundation
- First National Bank
- M&T Bank Foundation
- Martin M. Sacks Memorial Fund, a fund of The Foundation for Enhancing Communities
- Arts for All Partnership, a partnership between the Cultural Enrichment Fund and the Greater Harrisburg Community Foundation, a regional foundation of The Foundation for Enhancing Communities

Schools

We completed 15 school visits in 2019, and covered the states of Pennsylvania, Delaware, New York, New Jersey, and Kentucky.

Students

During these 15 visits we had an opportunity to have workshops in front of 1,929 students. Over 1,900 students submitted a Flash Fiction, which is a short one-page story of what a fictional topic they

developed. From these Flash Fiction submissions, we have selected 15 students to start the process of a complete story, with illustrations, and then publication of at least 200 copies of the student's books. These books will be published 2020.



Books

Each student that is selected to write their book will have a legal contract signed by their guardians. This contract will provide the student final say in the content of the book. In addition, the student will be received 20% royalty on the net profit of the sale of their book, with NO costs to them or their guardian.

At each school visit we ask the sponsoring administration person to provide us feedback on our efforts. We are proud to report the following

<u>Presenters effectiveness:</u> Average of 98.3% with no score below 90%

Students level of excitement: Average of 93.8% with no score below 70%
