MESSAGE FROM ROBERT E. CAPLAN - CHAIR

The United States equity markets climbed during the first quarter of 2023 despite an unexpected and disruptive banking crisis. The S&P 500 moved up seven and a half percent, including dividends, during the first quarter. Although the market trended well during Quarter 1, the market remains concerned about the Feds' mission to tackle persistent inflation by increasing interest rates. Raising rates will ultimately have a negative impact on corporate earnings and the Foundation's Investment Advisory Committee predicts that the economic slowdown will keep volatility with us into the summer.



The value of bonds has been dramatically impacted by the effect of a staggering nine interest rate hikes in the past twelve months. The Fed's activity has improved short-term bond yields to a very attractive five percent. At The Foundation, we avoid bond risk by maintaining a less volatile short to intermediate-maturity bond strategy.

History has proven that investors who expend time and effort to predict the future direction of the market are consistently outperformed by the passive, market-neutral index approach employed by The Foundation. At TFEC we are confident that staying invested and well-diversified provides the greatest, most consistent investment returns.






70% EQUITY & 30% FIXED INCOME (MODEL A)

EARLY CHILDHOOD INITIATIVE

TFEC EARLY EDUCATION INITIATIVE HOSTS VIRTUAL EARLY LEARNING CONFERENCE



On March 20-24, 268 administrators, teachers, agencies, students, and preschool providers from TFEC's five county footprint gathered together virtually to share professional development training within the realm of early education. Participants' home counties included Cumberland, Dauphin, Perry, Franklin and Lebanon, along with Allegheny, Chester, Clearfield, Montgomery, Lancaster and York.

All conference sessions fit into **The Basics** principles and participants were able to view a refresher session on **The Basics** if they had missed it in last year's conference. **The Basics** are five evidence-based caregiving principles that encompass what experts find is important for children from birth to age five. The most watched session this year

was Building Hope with Fred Roger's Blueprint. Even now, Fred Roger's work is relevant and fits perfectly with The Basics. One of Mr. Rogers' greatest gifts was to encourage simple interactions between caregivers and children. He also invited viewers to think and wonder, to be scientists: To Explore Through Movement and Play.

Children explore and learn about the world through movement and play. There are many kinds of play: exploring objects using the five senses, pretend and imaginative play, creative activities such as painting or playdough, and physical play, such as throwing a ball. Movement and play keep children healthy and build their coordination and strength.

How to incorporate Explore Through Movement and Play in everyday activities:

Go Outside Together.

Ask a child to describe the weather using some of their senses (eyesight, hearing, taste, touch, and smell). Share something that you like about whatever season you are in.

Practice Problem Solving.

See if a child can think about different ways to solve a problem. When a toy breaks, they could play doctor and try to fix it. Or they could pick a different toy in which to play.

Mystery Bag.

Be a scientist and play guessing games together. Put a few objects in a bag and take turns guessing what is inside without looking. You can feel, smell, or shake the bag.

Two New funds in 2023: Creative Sector Flex Fund and Madden Family Foundation Fund.

Creative Sector Flex Fund

The Pennsylvania Council on the Arts (PCA) is excited to introduce a new grant program, the Creative Sector Flex Fund (CSFF), for the 2023-2024 grant year. The CSFF is designed to address the changing needs of dynamic PA arts organizations with average annual revenue between \$10,000 — \$200,000. This grant program incorporates the current needs of the field by offering grantees the flexibility to use \$5,000 grants in ways that ensure the most significant impact for their organizations and communities. The Creative Sector Flex Fund provides support to eligible applicants that provide consistent annual levels of artistic programming and/or arts services in Pennsylvania. One application per applicant per year may be submitted. Eligible uses of funds are flexible, including the support of applicants' administrative, programmatic, and project-related expenses.

Madden Family Foundation Fund

The mission of the Madden family is to empower underprivileged children and to promote their education in order to break the cycle of poverty. The Madden's seek to provide equal access to high-quality education and resources through partnerships with schools, programs, and communities. They believe in investing in the potential of children and are dedicated to supporting and inspiring them to achieve their goals. The Madden Family Foundation Fund invites established 501(c)(3) nonprofit organizations to submit proposals to support disadvantaged mothers with children. Grants are awarded to eligible nonprofit organizations serving the south central PA counties of Cumberland, Franklin, Lebanon, Dauphin, Perry and/or northern York Counties.

Martin M. Sacks Memorial Fund

The Martin M. Sacks Memorial Fund, a fund of The Foundation for Enhancing Communities, was established in 1984 in memory of Martin M. Sacks, a well-known accountant and handball devotee. Mr. Sacks was committed to supporting nonprofit organizations that provide programs and services for the disadvantaged and underserved, particularly youth. The Martin M. Sacks Memorial Fund invites established 501(c)(3) nonprofit organizations to

submit proposals to support youth and family oriented programs and services that are consistent with the mission of your agency. Grants are awarded to eligible nonprofit organizations serving the south central PA counties of Cumberland, Dauphin, and/or Perry Counties. Preference will be given to programs and/or services that are provided to or within Harrisburg and the immediate surrounding areas. The committee seeks to support innovative activities that directly benefit at-risk children, youth, and their families.

The Fund for Women & Girls

The mission of The Fund for Women & Girls, a special initiative of The Foundation for Enhancing Communities, is to broaden the awareness of and response to issues affecting women and girls through the power of collective philanthropy. The Fund for Women & Girls believes that positive social change will come about only when barriers of class, economic status, educational background, ethnicity, educational background, faith traditions, gender identity, race, and sexual orientation are overcome to further its mission, The Fund for Women & Girls utilizes three Funding Priorities which seek to support projects that advance the lives of girls and women by: providing opportunities to address basic needs or develop economic self-sufficiency; strengthening and/or providing health and safety programs for women and girls; and promoting the education of women and girls. The Fund for Women & Girls will make grants to programs and initiatives that serve women and girls in the south central PA counties of Dauphin, Cumberland, Franklin, Lebanon, Perry, and the Dillsburg area of York County. In addition, each Fund for Women & Girls Grantee Recognition Breakfast held annually in the Spring.

Greater Harrisburg Community Foundation Benjamin Franklin Trust Fund

Benjamin Franklin once stated, "An investment in knowledge always pays the best interest" and today, Franklin's legacy lives on at TFEC through the GHCF Benjamin Franklin Trust Fund. Fueled by funds directed by Franklin's last will and testament in 1789 and distributed to community foundations throughout the Commonwealth of Pennsylvania, today the Benjamin Franklin Trust Fund is pleased to support our local communities through this unique grant opportunity. The GHCF Benjamin Franklin Trust Fund grant opportunity seeks to support programs and services that work to increase knowledge and/or quality of life or that inspire positive outcomes for individuals and families living in the service area of Cumberland, Dauphin, Franklin, Juniata, Mifflin, Lebanon, and Perry Counties, and/or the Dillsburg area of York County. Eligible projects must serve individuals, groups, and/or locations within Cumberland, Dauphin, Franklin, Juniata, Mifflin, Lebanon, and Perry Counties, and the Dillsburg area of York County. In honor of the period during which Franklin lived, the maximum grant is \$1,700.

Greater Harrisburg Community Foundation UPstream

The Greater Harrisburg Community Foundation (GHCF) UPstream grant opportunity seeks to improve our area communities by supporting existing or new "upstream" systems, interventions, programs, or projects that attempt to create positive social change by addressing a problem at its source rather than managing its "downstream" symptoms. This grant opportunity is open to singular or collective nonprofit organizations whose proposals will serve the GHCF service area of Cumberland, Dauphin, Franklin, Lebanon, and/or Perry Counties and the Dillsburg area of York County. GHCF UPstream is available to organizations of all sizes, budgets, and reaches. The number of grant awards will be dependent upon the quantity of qualified applicants and funds sought.

In 2023 up to \$250,000 in grant funds will be available through GHCF UPstream. Applicants may seek support for any UPstream project, program, or intervention that best meets the needs of the population to be served. GHCF UPstream is additionally pleased to encourage applications that focus upon education, environment & parks, health & wellness, homelessness & hunger, mental health, seniors, and communities of focus. TFEC may introduce other "focus areas" as community needs present themselves and these will be supported by unrestricted or new area of interest funds within the GHCF umbrella.

2021 GRANTEE SUCCESS STORIES

A LOOK BACK ON THE IMPACT OF TFEC'S GRANTS

The number of students served this year was well beyond our expectations and almost beyond our capacity. In the total project 76 students across Dauphin, Perry, and Cumberland County were served, nine more students than previous years in Perry County.

Center for Advance Teaching and Learning Project Title: Rapid Response Intervention Perry County Community Foundation 2021 Grantee Recipient of \$2,000 Total number of individuals served: 76

Project and Community Need:

The purpose of this project was to increase mental health and social worker support through CAIU's Rapid Response Team for students at risk of suspension or expulsion from early childhood environments. The project targeted families of young children between the ages of 0-5 with an increased emphasis on the 3-5 population. The social worker and behavior consultant provided support to early childhood centers and teachers and supported the retention of 13 students in their early childhood

programs. The social worker helped families connect with community resources across the county.

Success:

Within Perry County we served 13 different students in preschool centers and early childhood environments. The number of students we served this year was well beyond our expectations and almost beyond our capacity. In the total project we served 76 students across Dauphin, Perry, and Cumberland County. This year we served nine more students than previous years in Perry County. These funds allowed us to expand access in Perry County which tripled the number of students served. Grant funds were used to outreach to families and connect families to community resources within the county. Social work referrals came from community preschools and CAIU's early intervention program. The social worker helped families connect with behavioral health resources, medical assistance, county displacement resource, grandparent resources, housing, and local county ministries.

Project and Community Need:

The Mary Ritner Boarding House/John Brown House is a historic house site in the Borough of Chambersburg which was placed on the National Historic Register in 1970, and placed on the National Underground Railroad Network to Freedom, part of the

National Park Service in 2009. In order to maintain best stewardship of the site, it was in dire need of exterior painting and extensive carpentry work (20′ X 20′) under the painting as the siding was wet and needed to be replaced on the northern side and around a window sill on the western side of the building. Both areas were disintegrating.

Success:

Completing this work has enabled us to keep promoting this historic house site and, while the tourism numbers are still down, we continue to be optimistic that the number of tourists will increase as we move away from COVID-19 and racial reconciliation has come to the forefront of today's culture.

The Farmers Market is held each Thursday afternoon, May through October, on the grounds of the Cocoa Beanery. The market supports over 25 local vendors selling locally grown fruits and vegetables, dairy products, meats, baked goods, and other specialty items. It benefits over 50 local small businesses, artisans, and musicians. The market serves over 8,000 people annually and provides over 1,000 free health screenings and education sessions by Penn State Health Milton S. Hershey Medical Center health professionals.

It offers weekly health programming at the Market and hands-on activities and highlights cooking tips and recipes for using the fresh produce from the market.

SAMUEL ABRAMS FOUNDATION | DEADLINE: JUNE 30

Samuel L. Abrams, a Harrisburg businessman, distinguished himself during a lifetime of participation in his community through philanthropic, social and political activities. Born in Lithuania, Mr. Abrams immigrated with his parents to the United States and Harrisburg at the age of three. He attended Harrisburg city schools, graduating from Harrisburg Technical High School in 1922. After obtaining his degree in business administration from Penn State, he joined B. Abrams & Sons, the scrap metal processing firm that his father, brother and he founded. When Mr. Abrams attended Harrisburg Tech, he took a commercial curriculum because he had not believed that his family could afford to send him to college. At his graduation, though, when he realized that most of his friends were going to college, he decided that he wanted to go as well. By the time he graduated from Penn State in 1926, he had been instilled with a strong appreciation for the value of a college education.

In 1966, shortly after completing eight years as a member of the board of directors of the Harrisburg School District, Mr. Abrams established the Samuel L. Abrams Foundation to help deserving graduates and faculty members of the Harrisburg School District further their educations and obtain undergraduate and graduate degrees.

Governor George Leader was born in York County in 1918. His term as Governor of Pennsylvania in the 1950's was the highlight of his life. He was a champion for those with disabilities as well as education and worked hard to bring about positive change in both areas. Mr. Leader was a man of convictions and was not always right, but when he believed in something he fought to the end to achieve his objective.

He started his Leader Nursing Centers in 1962 to provide a better option for senior health care in Pennsylvania. His interest in nursing began with this venture. Mr. Leader was very interested in providing education for Licensed Practical Nurses (LPN's) and employed many of them in his nursing homes. This scholarship is for a legal resident of Cumberland, Dauphin, Lancaster, or York county who has been accepted into HACC's LPN program.


