MESSAGE FROM ROBERT E. CAPLAN - CHAIR

The Foundation for Enhancing Communities' supporters have had plenty to celebrate in 2023! The 100% equity portfolio appreciated 22.36% during the year which was a welcomed turnaround from 2022's negative performance. The socially responsible ESG portfolio advanced 28.26% and the balanced 70% equity and 30% fixed income portfolio also had a spectacular 2023 appreciating 17.23%. TFEC's 100% fixed income portfolio had a respectable 2023 increasing 5.77%. Easing inflation, a resilient economy, and the prospect of lower interest rates encouraged investors to buy, particularly in the last two months of the year.

A LOOK BACK ON THE IMPACT OF TFEC'S GRANTS



Boys and Girls Club of Chambersburg and Shippensburg Franklin County Community Foundation 2022 Grantee Recipient of \$2,000 Total number of individuals served: 122

Project and Community Need:

BGCCS serves several high-need communities in Franklin County: Chambersburg and Tuscarora. Local crime data for 2018 shows the Borough of Chambersburg reported

641 level-one offenses, which are violent felonies, more than all other local jurisdictions combined. The Borough of Chambersburg, according to U.S. Census data, also leads the county in total population (20,734), poverty level (18.1%), and diversity. Tuscarora falls below average on student equity marks. Test scores for students from low-income households fall below the state average by more than 50%. Children who experience poverty are at an increased risk of perpetrating or being victims of violent crimes, especially during the hours just after school. The Positive Action program is a comprehensive, cohesive social-emotional learning curriculum proven to help children develop self-management skills and responsible decision-making. Youth develop self-awareness and gain the social-emotional learning competencies they need for success. The program has been shown to improve conflict resolution, school safety, and positive youth development while reducing violence, bullying and substance abuse. This is an evidence-based program that is rated as effective by national research clearinghouses. Grant funds were used for direct care staffing to implement the program during 2022-2023 BGCCS's after-school care programs at three existing Chambersburg locations.

Success:

One success is that having the Positive Action program has provided a framework for increasing behavioral and mental issues we are seeing. The program gives us a language and connection point for children who are struggling. Schools are also now using Positive Action, creating congruence between school and the after-school program.



New Hope Ministries

Mechanicsburg Area Community Foundation 2022 Grantee Recipient of \$10,000 Total number of individuals served: 4,762

Project and Community Need:

New Hope Ministries is a non-profit organization that offers assistance to Mechanicsburg area residents in need. We provide basic resources such as food,

housing, heat and utilities, transportation, workforce development, and job training to low to moderate-income individuals and families. Our services are aimed at helping those who are facing financial crisis, including single parents, seniors living in poverty, and the working poor (known as ALICE: Asset Limited Income Constrained Employed). We meet people where they are and provide them with the tools and resources needed to achieve self-sufficiency. In the context of this grant, we served a total of 4,762 individuals from 1,667 families residing in the 17050 and 17055 zip code. This represents an increase of over 30% from the same time period last year.

Success:

"There were so many successes at our Mechanicsburg Center over this past year. We would like to highlight Ms. Chepkong, a Mechanicsburg resident who attended our April 2023 nurse aide pre-clinical class. She did superb during the pre-clinical training and has passed her two nurse aide state exams to earn her nurse aide certification. We just found out she recently started a new job," said Michelle Zemba, Development Coordinator, New Hope Ministries.

Operation Wildcat was formed in 2006 to pool the resources in the community to help school district students and families in need. The scholarship is for any student enrolled in the Mechanicsburg Area School District, planning on attending a 4 year school, 2 year school or trade school post high school graduation, full time, having a minimum 2.5 GPA, involved in community service and demonstrates a financial need.

Nick Pantalone Memorial Scholarship Fund

The Nick Pantalone Memorial Scholarship Fund honors Nicholas "Nick" Pantalone who was a brother, son, friend and Four Diamonds child. He passed away in 2013 from a 3 year battle with desmoplastic small round cell tumor, an extremely rare yet aggressive form of cancer that creates large masses in the abdomen that can spread to vital organs if gone undiagnosed. This disease is so rare that fewer than 200 cases have been reported and it has a 15% 5-year survival rate.

Nick possessed a love for life and was blessed with a heart of gold. For the 19 years that he lived on this earth, he touched the lives of many with his optimistic words, caring demeanor and encouraging spirit. Whether he was acting in school plays or working as a ride operator at Hersheypark, he was a role model and positive example for all who knew him. Though his battle with cancer was strenuous, he never complained; his grace and courage made him an inspiration to all who knew him.

FAFSA CHANGES
Spring 2023, Federal Student Aid office announced that it would be making changes to the Free Application for Federal Student Aid (FAFSA) form:

- Make it streamlined and easier for students
- New need-based calculator, Student Aid Index (SAI)
- Delayed release from October to December

January 2024, Federal Student Aid office announced an error in the form calculation which would further delay results.

• Updated results would start coming out in March 2024

Student Aid Index (SAI) is the new eligibility index number that is used to calculate need.

- Reduces the number of items considered
- Does not include the number of family members in college in the calculation

The formula considers

- Both taxed and untaxed income
- Also any assets and benefits received, such as unemployment or Social Security.

In response we have made the following changes to the application:

- No longer require students to upload the FASFA Submission Summary but the confirmation page or last year's **FASFA Submission Summary**
- Require the estimated Student Aid Index (SAI)
- Or to use the Federal Student Aid Estimator Calculator
