The final quarter of 2021 brought a more optimistic outlook following the third-quarter's concerns about COVID-19 and rising inflation. Despite news of a new Omicron variant and another wave of infections, COVID-19 cases remained less severe overall than last winter as vaccination rates continued to climb. Inflation concerns persisted, but moderated, as supply chain bottlenecks eased and inventories grew, and Congress passed a government funding bill relatively easily, avoiding a potential year-end shutdown.



Adding to one of its strongest years over the past decade, the U.S. stock market, as represented by the S&P 500 Index, saw robust returns in Q4. Small cap stocks also posted solid returns for the quarter and the year despite falling briefly into correction territory in late November amid the initial uncertainties over the Omicron variant.

International developed market stocks were also positive, while emerging markets were modestly negative due primarily to China's regulatory crackdown.

Looking toward 2022, the American economy should remain healthy thanks to strong corporate profits and robust consumer spending, but inflation pressures and other headwinds will likely temper growth. In terms of TFEC's portfolio performance, Model E finished the year up nearly 24%. All other Models tracked according to our expectations, reflecting strong S&P 500 performance in our equity positions while interest-rate sensitive corners of the market placed pressure on our bond-based investments. Meeting frequently throughout the year, our Investment Committee analyzes the current economic and market factors in play and remains committed to our tried-and-true investment strategy, which is founded on resiliency, conservative approaches to our Model allocations, and is built for long-term success.

I would like to thank the Investment Committee members and staff for conducting another year's worth of meetings virtually and never losing sight of our mission to support community members seeking to create long-lasting, meaningful impact. We are privileged to be part of this more than 100-year commitment by TFEC. As we march forward into 2022, best wishes for a healthy, happy and prosperous year ahead!







TFEC EARLY EDUCATION INITIATIVE HOSTS VIRTUAL EARLY LEARNING
CONFERENCE. ALL SESSIONS ARE PRERECORDED AND AVAILABLE FROM MARCH 14-18

In collaboration with the Lancaster-Lebanon IU-13, South Middleton School District, the United Way of Carlisle & Cumberland County, and the Waynesboro Area School District, TFEC will welcome Dr. Ron Ferguson, Founder and President of The Basics, to present his research and strategy for communities to support learning and brain development among preschoolers at this year's Early Learning Conference.

Dr. Ron Ferguson is an MIT-trained economist whose teaching and research for over 30 years at Harvard's Kennedy School have focused on social and economic challenges in American cities. Ron took a step into education when he found that cognitive skill gaps between different racial, ethnic, and socioeconomic groups are linked to early childhood experiences. With the help of a national advisory committee, Ron designed an approach to enhance early childhood experiences around five science-based caregiving practices entitled, The Basics. What began as a local program in Boston is now in more than 30 cities across the nation.

On March 14-18, administrators, teachers, agencies and preschool providers from TFEC's five county footprint will virtually gather together to hear how The Basics can support early learning strategies in many areas. Participants will then be able to build on this philosophy with additional breakout sessions. Topics include mental health and taking care of oneself, de-escalating behavior appropriately, supporting positive environments for children, English language learner techniques for teachers, resiliency and positive childhood experiences, conscious discipline techniques, and literacy in early learning.

TFEC has been offering transition forums and conferences in Dauphin County since 2012. This is the second year the conference was open to our entire service area of Cumberland, Dauphin, Franklin, Perry, and Lebanon counties.



NEW YEAR, NEW LOOK

The scholarship section of the TFEC website has a new look! After receiving feedback from our area students and school counselors, we have added resources to the web tailored by audience. FINDING THE RIGHT SCHOLARSHIP OPPORTUNITY HAS NEVER BEEN EASIER

In time for the new season, the options for searching all of the 150+ TFEC scholarships have expanded. Students can start on our main scholarship page and navigate their way to opportunities that are right for them using any of the added search categories.

STUDENTS ENROLLING IN A TRADE OR TECHNICAL SCHOOL

Students pursuing a trade or technical training after high school often count themselves out when looking for scholarship funding because they assume scholarships are only for students going to a four-year college. These students can now see a comprehensive listing of all TFEC scholarships that include students who are enrolling in a trade or technical school as eligible applicants.

SCHOLARSHIPS FOR YOUR SCHOOL DISTRICT

Our Search by County Feature has been expanded to include the option to narrow the search results down even further from County to School District. This search result creates a unique page with the most up-to-date information that is easily sharable by school counselors and linked to on social media. 
