# **INVESTMENT ADVISORY COMMITTEE**

#### MESSAGE FROM ROBERT E. CAPLAN - CHAIR

While we all are looking for good news wherever we can find it, the current state of affairs across the world is making the achievement of that goal challenging. However, there is some good news. We break down the current market conditions by the good, the bad, and the ugly, followed by our longer-term perspective on investing.

#### The Good

- Signs still point to a strong economy highlighted by a tight labor market and strong consumer balance sheets. Reopen trade, which is one where one buys stocks at attractive valuations that will benefit from an open economy, and perhaps rotate into attractively priced areas of the global stock market overall, is still evident.
- Payrolls for April came in weaker than expected, but there were positive revisions to the prior two months.
- The markets have largely priced in a significant amount of anticipated rate hikes, probably more than will actually occur.
- The unemployment rate dropped to 3.6% in April, which is nearly back to pre-pandemic levels. However, the mix among the sectors has changed. Despite continued gains in the Leisure/Hospitality sector, it is still significantly below its level in Feb 2020. There is continued improvement, though, in the labor force participation rate within this sector.
- The best performing sector in April was Consumer Staples (+2.6%).

#### The Bad

- Inflation continues to negatively impact consumers and producers. Market participants are looking for the peak to be reached in the next month or so as Fed rate hikes begin to be felt throughout the economy.
- The Federal Reserve is met recently and is expected to raise rates at least 50 basis points.
- A little over 55% of S&P 500 companies have reported Q1 results so far. Big earnings themes have revolved around economic normalization, continued supply chain and input price pressures, pricing power, improved labor supply, lagging tech results, and soft guidance and revision ratios. The Foreign Exchange, COVID lockdowns in China, and geopolitical tensions are the largest drags on earnings.
- As earnings season progresses, it is becoming evident that corporate profit margins are coming under pressure. The key to earnings growth in 2022 will be how companies preserve profitability in light of rising input costs and wages.

#### The Ugly

- The war in Ukraine and the lockdowns in China continue to weigh heavily from a humanitarian perspective as well as disrupting supply chains.
- S&P 500 is close to its 52-week low of 4,056 recorded on May 12, 2021.
- Volatility, as measured by the CBOE Volatility Index ("the VIX"), spiked in April, going from 23 to 33 as the month wore on. The VIX is a popular measure of expected volatility over the coming 30 days, and when it increases, it is an indication of rapid and significant price fluctuations on the S&P 500 and is associated with investor fears. As we discussed in our last quarterly webinar, relatively normal readings on this measure reside in the mid-to-high teens, but have moved into the high twenties and broke thirty several times this year as markets recalibrate to changing Fed policy and the impact of geopolitical events.
- The first look at the Q1 2022 GDP disappointed, down 1.4% versus expectations that it would be around 1%. This is the first decline in two years and is the result of reduced spending by the Government sector and a decline in exports of goods, despite stronger numbers for consumer spending on services. The first quarter 2022 GDP number will be revised in May, and again in June, as more data becomes available.
- Stocks in April
  - S&P 500 (large cap): -8.72%
  - NASDAO (technology): -13.24%
  - Russell 2000 (small cap): -9.91%
  - MSCI EAFE (international): -6.38%
- The worst performing sectors in April were Communication Services (-15.6%), Consumer Discretionary (-13.0%), and Technology (-11.3%).

# FEATURED BOARD MEMBER

## MARLENE KANUCK

Marlene Kanuck started her first year as a member of TFEC's Board of Directors in January 2022. Marlene was introduced to TFEC by board chair Carolyn Dumaresq, with whom she has been friends and colleagues with for years.



With a bachelor's degree in Natural Sciences, Marlene began her career teaching several science courses at Montour School District. She taught for 15 years, during which she implemented the state Student Assistance Program, a drug and alcohol/mental health program, in her district and the other districts in Butler County.

She moved to the PA Department of Education (PDE) in 1989, to become an SAP/safe schools, regional coordinator. Her 26-year tenure at PDE included advocating safe schools for LGBT students. In this capacity, she worked with Common Roads, a Harrisburg-based organization, to train over 600 high school personnel.

"Grantmaking, based on my previous roles with both the state and other organizations, feels like home to me. I am also very excited to learn more about the early education initiatives and the scholarship department, given my previous experience with those fields."

# WHAT DO YOU ENJOY MOST ABOUT BEING INVOLVED WITH TFEC?

In 2001, Marlene was a charter Board member of the LGBT Center in Harrisburg and served for ten years. In 2015, she was honored to receive the FAB award, given to those who have made an impactful contribution to the LGBT community in South Central PA. In 2012, Marlene became the Vice President of the Central PA Womyn's Chorus and liaison to the Harrisburg Gay Men's Chorus (HGMC). Presently she is serving on the Strategic Planning and Membership/Diversity committees for HGMC.

In 2014, Marlene was asked to speak by Equality PA at a rally for Marriage Equality about LGBT discrimination and in 2015 she was asked to join the Equality PA board which she served for a two-year tenure. In 2017 Marlene joined the board of Hershey Indivisible Team as Vice President. Soon after that, she presented an LGBT non-discrimination resolution to the Derry Township Supervisors, which was unanimously passed. Marlene can be found along with other LGBT community leaders in the recently published book "Out in Central Pennsylvania" (2020).

# **EARLY CHILDHOOD INITIATIVE**

# TFEC EARLY EDUCATION INITIATIVE HOSTS SOCIAL EMOTIONAL TRAINING SESSION VIA VIRTUAL CONFERENCE

On March 14-18, 117 administrators, teachers, agencies, students and preschool providers from TFEC's five county footprint gathered together virtually to share professional development training within the realm of early education. Participants' home counties included Cumberland, Dauphin, Perry, Franklin and Lebanon, along with Alleghany, Butler, Clearfield, Lawrence, Lycoming, Montgomery, Lancaster and York. Additionally, some participants viewed sessions from Maryland, Florida, and Ohio.

The most watched session of this year's conference was Classroom Supports for Social and Emotional Development and Curriculum presented by Jessica Jenkins, a Special Instructor and Behavior Specialist with Early Intervention Specialists and Alison Mellott, an Assistant Professor at Shippensburg University.

What is Social Emotional Learning (SEL) and why is it a popular topic right now? The Collaborative for Academic, Social, and Emotional Learning defines SEL as a process in which students grow and develop their lives and relationships. SEL concepts focus on creating a healthy, safe environment within five core competencies: self-awareness, self-management, social awareness, relationship skills, and responsible decision-making. These are all skills that are necessary to be successful in a career later on in life. SEL is about teaching students how to feel, not what to feel. It helps children to develop a perspective beyond their own, learn to see situations through the eyes of others, and to develop a shared emotional response. These are all skills that will be helpful in navigating everyday life in the future. Unfortunately, due to the pandemic, many students lack these skills from no fault of their own.

In a national survey of educators administered by the EdWeek Research Center in January, 39 percent of respondents said that "compared to prior to the pandemic in 2019, the social skills and emotional maturity levels" of their current students are "much less advanced." Forty-one percent said their students' were "somewhat less advanced," and 16 percent said they were "about the same" as their pre-pandemic peers. Children were just not given the opportunity to play, problem solve, think critically, or develop independence and empathy as much as they were in the past, before the coronavirus.

Yet, it is nearly impossible to teach and learn in a crisis without recognizing one's emotions. It becomes critical for teachers to support their students by building their social and emotional skills, and educators recognize this based on the views of the SEL session. Teachers learned during the session that SEL is about educators reshaping their own behaviors and approaches to teaching. Then a change can be made to impact the entire day overall, whether in a school or center setting. It is about weaving the principles throughout the curriculum in order to help both teachers and students have a productive day. It is encouraging to see the interest from professionals on how to meet the increased needs of area students and to strengthen communities.

In accordance with this mission, funding priority will be given in the following areas: human services, especially programs which address needs for food, clothing and shelter; education; cultural enrichment and the arts; funding is restricted to programs serving only disadvantaged children in Cumberland, Dauphin and Perry counties. Multi-year funding requests will be considered, but may be granted conditioned upon investment return, confirmation of matching funds identified by the Grantee, and/or the availability of foundation funds (in the years following the initial year of funding).

# **2020 GRANTEE SUCCESS STORIES**

#### A LOOK BACK ON THE IMPACT OF TFEC'S GRANTS

Central Pennsylvania Good Bank Perry County Community Foundation 2020 Grantee Recipient of \$3,500 Total number of children served: 445

#### Project and Community Need:

According to Feeding America, more than 1 in 9 Perry County children live with hunger. Hunger is more than a belly twinge between meals - it is a devastating lack of access to food. Hunger is damaging to people of all ages, but it is particularly harmful to children. Inadequate nutrition in childhood can permanently affect children's development, restricting their intellectual capacity, affecting their ability to learn, and impacting their social development. In addition, children facing food insecurity are at greater risk for anemia, asthma, oral health problems, and hospitalization. With the generous support of the Perry County Community Foundation, Central Pennsylvania Food Bank provided nutritious food and produce to children experiencing hunger in Perry County.

#### Success:

Central Pennsylvania Food Bank's greatest success was shifting our operating model to ensure that healthy food still got to the dinner tables where it was needed. Recognizing that if a child is hungry, the family is also hungry, we focused on establishing new School Pantry partners with school districts across Perry County. These best-practice pantries are more sustainable than traditional BackPack youth hunger initiatives. They provide more food that is higher-quality, and they can provide that for whole families. Perry County Community Foundation and The Foundation for Enhancing Community's generous support provided food to kids experiencing hunger during a scary, turbulent time.

Center for Employment Opportunities (CEO) Greater Harrisburg Community Foundation: UPstream 2020 Grantee Recipient of \$5,000 Total number of adults served: 119

#### Project and Community Need:

CEO is an evidence-based reentry program providing comprehensive employment services to individuals recently released from incarceration. CEO's program model (a workforce readiness training, transitional employment, job coaching and development (leading to job placement), and retention services) equips participants with the skills and resources to secure and sustain employment. Our services, particularly paid transitional employment, are essential to support our participants economically through the consequences of COVID-19.

#### Community Need:

Critical to an individual's success upon returning home from incarceration is the ability to find and maintain employment; however, social and economic barriers prevent returning citizens from realizing economic stability. At the time of submission, there were 6,374 individuals under supervision in Harrisburg, with the Board of Probation and Parole estimating that only 42% were able to secure full-time employment. Prior to COVID-19, the unemployment rate hovered at roughly 27% for this high-risk population. CEO's program intervened in the crucial moment immediately after release and provided a source of stable employment, income, and targeted workforce programming to support individuals as they returned home from incarceration and overcame barriers to finding and keeping a job despite the impacts of COVID-19.

#### **Success:**

The major success of CEO's program over this grant period and the calendar year 2021 was maintaining their services and even expanding their programming during the on-going COVID-19 Pandemic. Despite the challenges shared below, CEO exceeded our enrollment and transitional employment goals and nearly met their placement and retention goals. CEO believes the outcomes achieved over this grant period to be successful, especially given the impact of COVID-19 during this program year and the high-risk population that they serve. Also, as previously mentioned, CEO expanded their services this year with the addition of a new transitional work crew partnership with York Housing Authority, allowing them to serve even more individuals in need of their employment services.

TFEC provides numerous programs and services to the community. One of these services is our Fiscal Sponsor Program. Currently, TFEC proudly supports 72 Projects that are making a measurable difference in people's lives. Farmers Market in Hershey TFEC Project for 7 Years

The Farmers Market is held each Thursday afternoon, May through October, on the grounds of the Cocoa Beanery at 1215 Research Blvd., Hummelstown, PA, adjacent to the Hershey Center for Applied Research The market supports over 25 local vendors selling locally grown fruits and vegetables, dairy products, meats, baked goods, and other specialty items. It benefits over 50 local small businesses, artisans, and musicians. The market serves over 8,000 people annually and provides over 1,000 free health screenings and education sessions by Penn State Health Milton S. Hershey Medical Center health professionals. It offers weekly health programming at the Market and hands-on activities. We highlights cooking tips and recipes for using the fresh produce from the market. The market supports "Prescription Produce," a program in which Penn State College of Medicine students coach at risk youth and their families on healthy choices for eating. The market supplies fresh fruits, vegetables, and education to underserved and food insecure populations in our region. It provides a weekly, wholesome family and community gathering featuring music, local musicians, and a breadth of diverse talent.

Amanda Strous Flyhigh22 was named after Amanda Strous who was a daughter, sister, fiance, and mental health counselor. She was murdered in 2016 and her parents started the project to honor her legacy. The project supports the community in three areas:

- 1. Support victims of domestic violence
- 2. Those who need assistance any mental health area whether it be counseling, food, shelter, clothing, etc
- 3. Supporting the arts and art therapy
